- 2 GREENLEE, DIRECTOR OF THE LEGISLATIVE BUDGET OFFICE, UPON THE
- 3 OCCASION OF HIS RETIREMENT, FOR HIS EXCEPTIONAL SERVICE TO THE
- 4 JOINT LEGISLATIVE BUDGET COMMITTEE AND TO THE MISSISSIPPI
- 5 LEGISLATURE AND FOR HIS MANY CONTRIBUTIONS TO THE ADVANCEMENT OF
- 6 SOUND FISCAL MANAGEMENT WITHIN THE GOVERNMENT OF THE STATE OF
- 7 MISSISSIPPI.
- 8 WHEREAS, Robert Abraham "Bobby" Greenlee, the Director of the
- 9 Legislative Budget Office is retiring from Mississippi state
- 10 government after 39 years of service; and
- 11 WHEREAS, Robert Greenlee was born on October 8, 1936 in
- 12 Jackson, Mississippi and is the son of the late Maggie and Robert
- 13 Greenlee of Hermanville, Mississippi; and
- 14 WHEREAS, Robert Greenlee graduated from Port Gibson High
- 15 School in 1954 and furthered his education at the University of
- 16 Mississippi where he was a member of Sigma Alpha Epsilon
- 17 fraternity and where he received a bachelor of science degree in
- 18 business administration in 1959; and
- 19 WHEREAS, Robert Greenlee began his interest in state
- 20 government while still in college, serving as a driver for
- 21 Fielding Wright during Wright's 1955 campaign for his second term
- 22 as Governor; and
- 23 WHEREAS, Robert Greenlee, upon his graduation from the

- 24 University of Mississippi worked in the Ross Barnett gubernatorial
- 25 campaign and later served as a colonel on Governor Barnett's
- 26 staff; and
- 27 WHEREAS, Robert Greenlee began work at the Commission of
- 28 Budget and Accounting in January 1960 during the administration of
- 29 Governor Ross Barnett and continued his career there until April
- 30 1965 at which time he moved from Jackson to Port Gibson to serve
- 31 as assistant plant comptroller for Allied Chemical Company and
- 32 subsequently Oliver Electric Company; and
- 33 WHEREAS, Robert Greenlee returned to work at the Commission
- 34 of Budget and Accounting in 1968 as chief accountant and in 1973
- 35 was promoted to deputy director and went on to work a total of 23
- 36 years for the Commission of Budget and Accounting; and
- 37 WHEREAS, Robert Greenlee continued his service to the
- 38 Legislature upon the abolishment of the Commission of Budget and
- 39 Accounting in July 1984 by accepting the position of fiscal
- 40 control officer with the newly created Joint Legislative Budget
- 41 Committee and Legislative Budget Office; and
- 42 WHEREAS, Robert Greenlee was promoted to Director of the
- 43 Legislative Budget Office in September 1984 and continued in this
- 44 important position for over 15 years until his retirement on
- 45 January 31, 2000; and
- WHEREAS, Robert Greenlee prepared two biennial and fifteen
- 47 annual state budget recommendations for the Commission of Budget
- 48 and Accounting and prepared 16 annual state budget recommendations
- 49 for the Joint Legislative Budget Committee; and
- 50 WHEREAS, during his career with the Legislature, Robert
- 51 Greenlee has observed the State General Fund budget recommendation
- 52 increase from \$254 million for fiscal biennium 1962-1964 to \$3.6
- 53 billion for fiscal year 2000; and
- 54 WHEREAS, Robert Greenlee was married to his wife Mary Jane

- 55 Wilder of Greenwood on August 29, 1959, and they are the proud
- 56 parents of three children, Susan Greenlee South of Spring, Texas,
- 57 Charles Wilder Greenlee of Ridgeland, Mississippi, and Robert
- 58 Michael Greenlee who died in 1984; and three grandchildren, James
- 59 Robert South, Amy Elise South and Charles Wilder Greenlee, II; and
- 60 WHEREAS, Robert Greenlee is a member of Port Gibson United
- 61 Methodist Church where he serves as a teacher for an adult Sunday
- 62 School Class; and
- 63 WHEREAS, Robert Greenlee served for six years in the
- 64 Mississippi Air National Guard from 1959 to 1965 as an airman
- 65 first class, and
- WHEREAS, Robert Greenlee has served as a member of the Board
- of Directors of the Mississippi Southern Bank of Port Gibson since
- 68 1988 and is a member of the bank's finance committee; and
- 69 WHEREAS, Robert Greenlee is a member of the National
- 70 Association of State Budget Officers, which bestowed upon him in
- 71 May 1999 an honorary membership in recognition of his
- 72 contributions to state budgeting and in appreciation for his
- 73 service to the association; and
- 74 WHEREAS, Robert Greenlee has been instrumental in the
- 75 development of important measures to strengthen the state budget
- 76 process including the Budget Reform Act of 1992 which limited
- 77 appropriations to 98% of available funds and which created the
- 78 General Fund Stabilization Reserve that today has a balance of
- 79 over \$235 million; and
- 80 WHEREAS, Robert Greenlee has been an exceptionally qualified
- 81 and dedicated public servant who has devoted 39 years of his life
- 82 in service to the Legislature and the State of Mississippi and has

- 83 provided sound advice and counsel to legislators and state
- 84 agencies and institutions throughout this period:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 86 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 87 we do hereby commend Robert A. Greenlee for his outstanding
- 88 service to the Legislature of the State of Mississippi and wish
- 89 him success in his future endeavors.
- 90 BE IT FURTHER RESOLVED, That this resolution be presented to
- 91 Robert A. Greenlee and be made available to the Capitol Press
- 92 Corps.
