SENATE CONCURRENT RESOLUTION NO. 533
(As Adopted by Senate)

1 A CONCURRENT RESOLUTION COMMENDING WEYERHAEUSER COMPANY FOR
2 ITS CONTRIBUTIONS TO THE ECONOMY OF THE STATE OF MISSISSIPPI AND
3 CONGRATULATING WEYERHAEUSER COMPANY UPON THE CELEBRATION OF ITS
4 CENTENNIAL DAY.

5 WHEREAS, Weyerhaeuser Company was founded in Tacoma,
6 Washington, January 18, 1900; and

7 WHEREAS, Weyerhaeuser Company has grown to be an
8 international forest products company employing 45,000 people in
9 13 countries; and

10 WHEREAS, Weyerhaeuser Company has operated continuously in
11 Mississippi since 1956, and has more than 2,000 Mississippi
12 employees dedicated to producing and delivering high-quality
13 forest products; and

14 WHEREAS, Weyerhaeuser Company operates 17 separate factories
15 or offices in Mississippi communities, stretching from Olive
16 Branch to Magnolia; and

17 WHEREAS, Weyerhaeuser Company is a pioneer in sustainable
18 forestry practices and currently owns and manages approximately
19 627,000 acres of forestland in Mississippi, making it one of the
20 state's largest private landowners; and

21 WHEREAS, Weyerhaeuser Company manages its Mississippi forests
22 for values other than timber production, such as wildlife habitat

23 and recreation; and

24 WHEREAS, Weyerhaeuser Company is recognized as a global
25 leader in environmentally responsible manufacturing; and

26 WHEREAS, Weyerhaeuser Company operations exemplify its theme,
27 "The future is growing"; and

28 WHEREAS, Weyerhaeuser Company celebrated its Centennial on
29 January 18, 2000; and

30 WHEREAS, it is the policy of the Legislature to recognize
31 those organizations which have made contributions to the State of
32 Mississippi:

33 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
34 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
35 we do hereby commend Weyerhaeuser Company for its contributions to
36 the economy of the State of Mississippi and congratulate it upon
37 the celebration of Weyerhaeuser Company Centennial Day.
