- 3 WHEREAS, Brigadier General Ernest R. Webster, a native of
- 4 Anguilla, Mississippi, is retiring from the United States Air
- 5 Force after a 33-year distinguished career in the military,
- 6 spanning from March 28, 1967, to April 3, 2000; and
- 7 WHEREAS, General Webster is Commander of the Air Force
- 8 Reserve Command's 403rd Wing at Keesler Air Force Base,
- 9 Mississippi, where he is responsible for the training, equipping
- 10 and mission of the 403rd Wing and subordinate units located at
- 11 Little Rock Air Force Base, Arkansas; and
- 12 WHEREAS, General Webster attended Arkansas State University,
- 13 participating in the Reserve Officer Training Corps and earned a
- 14 Bachelor of Science degree in management; and
- WHEREAS, in January 1967, General Webster entered the United
- 16 States Marine Corps and was commissioned a Second Lieutenant; and
- 17 WHEREAS, General Webster left the Marine Corps after serving
- 18 tours of duty with a Caribbean readiness force and at Hui Phubai,
- 19 Republic of Vietnam, and entered the Air Force in January 1972;
- 20 and
- 21 WHEREAS, since that time, he has served as Chief of Aircraft
- 22 Maintenance; Flight Examiner; Chief of Safety, Operations and
- 23 Training Office; Squadron Commander, Group Commander, Deputy Chief
- 24 of Staff for Operations (14th Air Force and Headquarters Air Force
- 25 Reserve); and Wing Commander; and
- 26 WHEREAS, over the years, General Webster furthered his

- 27 education and training by attending Post Maintenance Test Pilot
- 28 School in Santa Ana, California (1971); Maintenance Officer School
- 29 at Chanute Air Force Base, Illinois (1972); Squadron Officer
- 30 School (1976); Aircraft Accident Investigation School at the
- 31 University of Southern California (1976); Air Command and Staff
- 32 College (1976); National War College at Fort Elsie J. McNair in
- 33 Washington, D.C. (1985); and Embry Riddle Aeronautical University,
- 34 where he obtained a master's degree in business administration
- 35 (1985); and
- 36 WHEREAS, throughout his career, General Webster has been
- 37 recognized with many awards and decorations, such as the Legion of
- 38 Merit with oak leaf cluster; the Meritorious Service Medal with
- 39 two oak leaf clusters; the Air Medal with 18 oak leaf clusters;
- 40 the Aerial Achievement Medal; the Air Force Commendation Medal;
- 41 the Navy Presidential Unit Citation; the Air Force Outstanding
- 42 Unit Award with five oak leaf clusters; the Air Force Organization
- 43 Excellence Award with oak leaf cluster; the Navy Meritorious Unit
- 44 Commendation; the Combat Readiness Medal with two oak leaf
- 45 clusters; the National Defense Service Medal with service star;
- 46 the Vietnam Service Medal with three service stars; the Southwest
- 47 Asia Service Medal with service star; the Humanitarian Service
- 48 Medal with service star; the Armed Forces Reserve Medal with oak
- 49 leaf cluster; the Organized Marine Corps Reserve Medal; the
- 50 Republic of Vietnam Gallantry Cross with Palm; the Republic of
- 51 Vietnam Campaign Medal; and the Kuwait Liberation Medal; and
- WHEREAS, General Webster was rewarded with many promotions
- 53 throughout his military career, beginning with his promotion to
- 54 Second Lieutenant on January 1, 1967; to First Lieutenant on April
- 55 1, 1968; to Captain on December 1, 1970; to Major on May 10, 1977;
- 56 to Lieutenant Colonel on December 14, 1981; to Colonel on August
- 57 1, 1985; and to Brigadier General on April 3, 1995; and
