SENATE CONCURRENT RESOLUTION NO. 589 (As Adopted by House and Senate)

- A CONCURRENT RESOLUTION TO COMMEND BRUCE HOLMES BRADY,
- 2 NATIONALLY-KNOWN ARTIST OF BROOKHAVEN, MISSISSIPPI.
- 3 WHEREAS, Bruce Holmes Brady, a lifelong resident of
- 4 Brookhaven, Mississippi, was born on June 28, 1934, to Tom P.
- 5 Brady and Lavern Holmes Brady; and
- 6 WHEREAS, Mr. Brady was a 1953 graduate of the Lawrenceville
- 7 School, Lawrenceville, New Jersey, the University of Mississippi
- 8 and the University of Mississippi School of Law; and
- 9 WHEREAS, known as an attorney, journalist, writer,
- 10 outdoorsman, philanthropist, sculptor, husband, father and friend,
- 11 he enriched the lives of many; and
- 12 WHEREAS, he practiced law for 10 years in Brookhaven before
- 13 becoming an editor for <u>Outdoor Life</u> magazine in 1972; and
- WHEREAS, he later penned a memoir of his outdoor experiences
- 15 in his first book, <u>Bruce Brady's Game Trails</u>, an anthology of his
- 16 published hunting articles; and
- 17 WHEREAS, an award-winning artist, Mr. Brady became a
- 18 professional sculptor in 1983; his bronze works are in prestigious
- 19 private and public art collections from coast to coast, including
- 20 the private collections of President Ronald Reagan and Senator Bob
- 21 Dole; his commissioned works include the Charlie Connerly Memorial
- 22 Trophy on display at the Mississippi Sports Hall of Fame; and
- 23 WHEREAS, he was a Fellow in the American Artists Professional
- 24 League and a member of the Allied Artists of America and the
- 25 National Sculpture Society; and
- 26 WHEREAS, he was the 1994 Featured Sculptor of the

- 27 Southeastern Wildlife Art Exposition; and
- 28 WHEREAS, he served on the advisory boards of the Lauren
- 29 Rogers Museum of Art and Trustmark National Bank and was a trustee
- 30 of the Mississippi Chapter of the Nature Conservancy; and
- 31 WHEREAS, Mr. Brady's conservation efforts earned him numerous
- 32 honors and the respect of outdoorsmen nationwide; he was named
- 33 Sportsman of the Year by the Shikar Safari Club International,
- 34 Outdoor Communicator of the Year by the Mississippi Wildlife
- 35 Federation, received the WLBT Spirit of Mississippi Award, and was
- 36 inducted into the North American Sheep Hunters Association Grand
- 37 Slam Club; and
- 38 WHEREAS, he received the President's Award for Lifetime
- 39 Achievement from the Mississippi Wildlife Federation in gratitude
- 40 for outstanding service and commitment to the conservation of
- 41 Mississippi's natural resources; and
- WHEREAS, Mr. Brady's philanthropic activities included both
- 43 his talent and time as he donated works to Art for the Heart, UMC
- 44 Candlelighters, the Diabetes Foundation and numerous other
- 45 charities; and
- WHEREAS, in recognition of his dedication to wildlife
- 47 conservation, the Mississippi Wildlife Federation has created the
- 48 Bruce Brady Catch-a-Dream Foundation to provide outdoor adventures
- 49 for critically ill children; and
- 50 WHEREAS, Mr. Brady was a lifelong member of First Baptist
- 51 Church of Brookhaven where he was a deacon and served as past
- 52 chairman of deacons, a Sunday school teacher and encouraged the
- 53 church's emphasis on mission work; and
- 54 WHEREAS, it is with deep sorrow that this Legislature extends
- 55 its sympathy to his wife, Peggy Faires Brady, son, Bruce Brady,
- 56 Jr., his daughters, Janie Brady Mooney and Becky Brady Taylor, his
- 57 brother, Thomas Pickens Brady, Jr., as well as thirteen
- 58 grandchildren and a host of friends on the passing of a man who
- 59 has been a source of inspiration and encouragement to all whose

- 60 lives he touched, and who did honor to his beloved Mississippi:

- 62 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
