SENATE CONCURRENT RESOLUTION NO. 636

1 A CONCURRENT RESOLUTION CREATING A JOINT STUDY AND OVERSIGHT 2 COMMITTEE TO REVIEW THE POULTRY PRODUCTION INDUSTRY IN MISSISSIPPI 3 AND MAKE RECOMMENDATIONS THEREON; TO DIRECT THE JOINT COMMITTEE TO 4 MAKE A WRITTEN REPORT OF ITS FINDINGS AND RECOMMENDATIONS BEFORE 5 DECEMBER 1, 2000; AND FOR RELATED PURPOSES.

6 WHEREAS, the production of poultry constitutes an important 7 and significant portion of the state's economy and it is 8 beneficial to the citizens of this state to protect the vitality 9 of this enterprise:

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF 10 11 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That a Special Joint Study and Oversight Committee is created to Review 12 13 the Poultry Production Industry in Mississippi and make 14 recommendations thereon. The joint committee shall examine the status of poultry-growing arrangements and fair practices in 15 16 Mississippi. The joint committee shall also monitor the use of funds provided by the 2000 Legislature to the Mississippi State 17 University Cooperative Extension Service and the Veterinary 18 Diagnostic Laboratory to supply poultry producers and processors 19 with additional specialists and services. The joint committee 20 21 shall be composed of twelve (12) members as follows: the Chairmen of the Senate and House Agriculture Committees, who shall serve as 2.2 23 co-chairmen, the Chairmen of the Senate and House Appropriations Committees, the President Pro Tempore of the Senate, the Speaker 2.4 25 Pro Tempore of the House, two (2) Senators to be appointed by the Lieutenant Governor, two (2) Representatives to be appointed by 26 27 the Speaker of the House, the Attorney General and the Mississippi

29 Within fifteen (15) days after sine die adjournment of the 30 2000 Regular Session of the Legislature, the Lieutenant Governor and Speaker shall make necessary appointments of the committee. 31 32 After the members are appointed, the joint committee shall meet on 33 a date designated by the co-chairmen in Jackson, Mississippi, to select a vice chairman who shall serve as secretary of the joint 34 35 committee, to organize the committee and establish rules for transacting its business and keeping records. An affirmative vote 36 of a majority of the members shall be required in the adoption of 37 38 rules, resolutions and reports. All members of the joint committee shall be notified in writing of all regular and special 39 40 meetings of the committee, which notices shall be mailed at least five (5) days before the dates of the meetings. 41

The joint committee may establish any subcommittees that it deems desirable to study and report to the committee with respect to any matter that is within the scope of this resolution.

The joint committee shall make a written report of its findings and recommendations, and shall mail copies of the report to each member of the Legislature not later than December 1, 2000.

In carrying out the provisions of this resolution, the joint 48 committee may utilize the services, facilities and personnel of 49 all departments, agencies, offices and institutions of the state, 50 including the state universities and the community and junior 51 52 colleges. In particular, the joint committee shall consult with the Mississippi State University Cooperative Extension Service and 53 54 the Veterinary Diagnostic Laboratory which shall cooperate with the committee and provide the committee with any information and 55 56 other assistance requested by the committee. The joint committee 57 may consult and seek advice from various groups in the state in order to understand the effect of any existing laws or any changes 58 59 in law being considered by the committee.

For attending meetings of the joint committee, each legislative member shall be paid per diem compensation in the amount authorized by Section 25-3-69 and a mileage allowance and an expense allowance in the amount authorized by Section 5-1-47, to be paid from the contingent expense fund of the member's

respective house. Nonlegislative members shall not receive per 65 diem compensation but shall be entitled to expense reimbursement 66 67 for any necessary travel. However, no per diem compensation, 68 mileage allowance or expense allowance shall be paid for attending meetings of the joint committee while the Legislature is in 69 70 session, and no per diem compensation, mileage allowance or 71 expense allowance shall be paid without prior approval of the 72 proper committee in the member's respective house.
