SENATE CONCURRENT RESOLUTION NO. 666
(As Adopted by Senate)

1 A CONCURRENT RESOLUTION CONGRATULATING AND COMMENDING
2 MISSISSIPPI EMPLOYMENT SECURITY COMMISSION EMPLOYEES RAYMOND
3 AUSTIN, JR., BEN MAYNOR, AL JONES, DORIS CERANTI AND LYNN EUBANK,
4 INDIVIDUALLY AND AS A GROUP, ON THEIR COMBINED MESC EMPLOYMENT
5 SERVICE OF 128 YEARS, 2 MONTHS AND 18 DAYS, ON THE OCCASION OF
6 THEIR RETIREMENT.

7 WHEREAS, Raymond Austin, Jr., Ben Maynor, Al Jones, Doris
8 Ceranti and Lynn Eubank celebrated their retirement at a special
9 reception held in their honor on Friday, April 21, 2000, at the
10 Mississippi Employment Security Commission office in Clarksdale,
11 Mississippi; and

12 WHEREAS, these five long-time employees of MESC have
13 dedicated and devoted their lives to the Mississippi Employment
14 Security Commission and to the State of Mississippi with their
15 faithful and distinguished service, both as a group and
16 individually; and

17 WHEREAS, Raymond Austin, Jr., began his career with MESC on
18 November 3, 1969, and is retiring (current position--Manager of
19 Unemployment Insurance Office, Clarksdale) with 30 years', 5
20 months' and 28 days' service with MESC; and

21 WHEREAS, Ben Maynor began his career with MESC on August 28,
22 1972, and is retiring (current position--Unemployment Insurance
23 Tax Field Representative, Clarksdale) with 27 years', 8 months'
24 and 3 days' service with MESC; and

25 WHEREAS, Al Jones began his career with MESC on September 10,
26 1975, and is retiring (current position--Manager of Employment
27 Service Office, Clarksdale) with 24 years', 7 months' and 21 days'
28 service with MESC; and

29 WHEREAS, Doris Ceranti began her career with MESC on March 5,
30 1976, and is retiring (current position--Employment Security
31 Placement Supervisor, Clarksdale) with 24 years', 1 month and 26
32 days' service with MESC; and

33 WHEREAS, Lynn Eubank began her career with MESC on February
34 1, 1979, and is retiring (current position--Employment Security
35 Aide III/Lead Terminal Operator) with 21 years', 3 months' and 0
36 days' service with MESC; and

37 WHEREAS, Raymond Austin, Jr., Ben Maynor, Al Jones, Doris
38 Ceranti and Lynn Eubank (all retiring from the Clarksdale MESC
39 office) have a remarkable combined total of 128 years, 2 months
40 and 18 days' service with the Mississippi Employment Security
41 Commission; and

42 WHEREAS, it is the policy of the Legislature to recognize and
43 honor the accomplishments and achievements of citizens of this
44 state, and especially those who have devoted their lives and
45 faithful service as employees of the State of Mississippi:

46 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
47 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
48 we do hereby congratulate and commend Raymond Austin, Jr., Ben
49 Maynor, Al Jones, Doris Ceranti and Lynn Eubank on the occasion of
50 their retirement after these many years of faithful service to the
51 Mississippi Employment Security Commission and the State of
52 Mississippi.

53 BE IT FURTHER RESOLVED, That Senator Delma Furniss is hereby
54 designated to represent this body in presenting this resolution to
55 each retiree and wish them well in a long and happy retirement.
