## SENATE CONCURRENT RESOLUTION NO. 667 (As Adopted by Senate)

A CONCURRENT RESOLUTION RECOGNIZING THE INAUGURAL CEREMONIES FOR DR. RONALD MASON, JR., PRESIDENT OF JACKSON STATE UNIVERSITY. WHEREAS, Dr. Ronald Mason, Jr., assumed the presidency of Jackson State University on February 1, 2000, bringing a wealth of experience in higher education, community development and legal issues; and

7 WHEREAS, at the time of his appointment by the Board of Trustees of State Institutions of Higher Learning, Dr. Mason was 8 9 serving as Executive Director for the Tulane-Xavier National Center for the Urban Community in New Orleans, Louisiana; and 10 WHEREAS, as founder and Executive Director of the 11 12 Tulane-Xavier Center, Dr. Mason coordinated the two universities' extensive involvement in public housing, economic development and 13 14 public education; and

WHEREAS, in this unique role, Dr. Mason oversaw the recovery for the housing authority, including the involvement of Tulane and Xavier faculty, students and staff in developing model programs to stimulate resident self-sufficiency and to implement welfare reform and welfare-to-work programs through the Tulane-Xavier Campus Affiliates Program and the Tulane Institute for Resident Initiatives; and

22 WHEREAS, during his 18 years at Tulane, Dr. Mason served in 23 several capacities, including Senior Vice President and General 24 Counsel, and Vice President for Finance and Operations; and 25 WHEREAS, his accomplishments at Tulane included establishing 26 the Tulane-Xavier-Loyola-Dillard Martin Luther King Week for Peace

30 WHEREAS, Dr. Mason was the principal investigator on a grant 31 awarded by the Ford Foundation to explore the issue of racism in 32 higher education with presidents of highly selective southern 33 universities, and spent six weeks in Kenya and Tanzania, East 34 Africa, as Tulane's representative on the Louisiana Consortium for 35 Higher Education; and

36 WHEREAS, Dr. Mason is involved in numerous public service 37 activities, including membership on the following boards: the 38 Southern Development Foundation, the University of Dayton and 39 First American Community Development Corporation; and

40 WHEREAS, Dr. Mason is the recipient of the Mayors Medal of 41 Honor from the City of New Orleans and the Martin Luther King 42 Lifetime Achievement Award from Dillard-Loyola-Tulane and Xavier 43 Universities; and

WHEREAS, as President of Jackson State University, Dr. Mason 44 will serve on the Boards of the West Jackson Community Development 45 46 Corporation; Capital Center, Inc.; Jackson Medical Mall Foundation; Mississippi Technology; and the Mississippi 47 48 Telecommunications Conference and Training Center Commission; and WHEREAS, Dr. Mason earned his BA and JD degrees from Columbia 49 50 University, and is also a graduate of the Harvard Institute of 51 Educational Management; and

52 WHEREAS, Dr. Mason is married to Belinda DeCuir Mason, and 53 has one daughter, Nia, and two sons, Jared and Kenan:
