SENATE CONCURRENT RESOLUTION NO. 668 (As Adopted by Senate)

1 A CONCURRENT RESOLUTION COMMENDING THE CAREER OF LT. COLONEL 2 BRUCE BRELAND, DEPUTY DIRECTOR OF THE MISSISSIPPI DEPARTMENT OF 3 PUBLIC SAFETY, UPON THE OCCASION OF HIS RETIREMENT AFTER 30 YEARS 4 OF SERVICE.

5 WHEREAS, Lieutenant Colonel Bruce Breland of Richland, 6 Mississippi, has announced his retirement as Deputy Director of 7 the Mississippi Department of Public Safety in charge of Support 8 Services; in this position, he oversees the day-to-day operations 9 of the Division of Support Services which has approximately 63 10 employees and is one of seven components under the Department of 11 Public Safety umbrella; and

12 WHEREAS, commissioned as a trooper in 1969, Breland served in the Gulfport District in enforcement until 1975 when he became an 13 Instructor at the Mississippi Law Enforcement Officers' Training 14 Academy; in 1980, Breland began working at the headquarters 15 16 building in Jackson as Director of the Implied Consent Branch, 17 becoming Director of the Driver Improvement Branch in 1982; in 1986, he was promoted to Captain and assigned as Director of the 18 Administrative Division of the Driver Services Bureau; in 1990, 19 20 Breland was promoted to Major and placed in charge of Support Services, being elevated in rank to Lieutenant Colonel in 1992; 21 22 and

23 WHEREAS, Breland graduated from Poplarville High School and 24 from the University of Southern Mississippi with a bachelor's 25 degree in Criminal Justice; he served aboard the U.S.S. Ault (D.D. 26 698) Destroyer in the United States Navy from 1966-1968 holding 27 the rank of Petty Officer 3rd Class; he retired from the

WHEREAS, Breland received special training in an instructor's 30 31 course at the Federal Law Enforcement Training Center in Glynco, 32 Georgia; special weapons and tactics training from the Federal 33 Bureau of Investigation; defensive driving training at Somerville, Massachusetts; police firearms instruction from the U.S. Treasury 34 35 Department; hazardous explosive devices training from Redstone Arsenal in Huntsville, Alabama; civil disturbance training at Fort 36 37 McCellen, Anniston, Alabama; and advanced scuba instructor's training at Jacksonville, Florida; and 38

39 WHEREAS, he is the son of Helen S. Breland and the late Hugo 40 Breland of Poplarville, Mississippi; he is married to the former 41 Rebecca Jo Quinn, daughter of Roy and Pearl Quinn of Richland; 42 they are the parents of three daughters: Michelle, Karen and 43 Robin, and one son, Brian; the Brelands are members of the 44 Richland United Methodist Church; and

45 WHEREAS, it is with great pride that we recognize the long 46 public service of this dedicated law enforcement professional, 47 whose expertise has enhanced the effectiveness of the Mississippi 48 Highway Patrol and brought great credibility and honor to his 49 department and to his state:

50 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF 51 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That 52 we do hereby commend the career and public service of Colonel 53 Bruce Breland, Deputy Director of the Mississippi Department of 54 Public Safety, upon the occasion of his retirement after a 30-year 55 career as a law enforcement professional, and wish him continued 56 success in his future endeavors.
