9 Amend by striking all after the enacting clause and inserting 10 in lieu thereof the following:

- 12 SECTION 1. Section 25-3-73, Mississippi Code of 1972, is 13 amended as follows:
- 25-3-73. From and after <u>July</u> 1, <u>2002</u>, all state and nonstate 15 service employees, as defined in Section 25-9-107, <u>other than</u>
 16 <u>academic officials</u>, <u>members of the teaching staffs and employees</u>
 17 <u>of the state institutions of higher learning and the Board of</u>
 18 <u>Trustees of State Institutions of Higher Learning</u>, shall be paid
 19 on a delayed basis twice a month. If such employees' payday falls
 20 on a state holiday as set forth in Section 3-3-7, or on a Saturday
 21 or Sunday, such employees shall be paid on the working day
 22 preceding such holiday, Saturday or Sunday.
- SECTION 2. An employee of a state agency may authorize, in 24 writing, a transfer each pay period from the employee's salary or 25 wage payment for a membership fee in an eligible state employee 26 organization. The written authorization shall remain in effect 27 until an employee, in writing, authorizes a change in the 28 authorization. Participation by employees of state agencies in 29 the payroll deduction program authorized by this section is 30 voluntary. To be eligible, a state employee organization must: 31 have a current dues structure for state employees in place; have

- 32been operating in the state for at least eighteen (18) months; and 33have at least two thousand five hundred (2,500) members.
- The deductions shall be made each pay period in an amount as 35 authorized by the employee. The state agencies or applicable pay 36 officer for the state shall pay over to the designated recipient 37 any funds collected through payroll deductions on a monthly basis. 38 The authorization for payroll deductions as provided in this 39 section shall be continuing unless terminated, in writing, by the 40 employee.
- 41 SECTION 3. This act shall take effect and be in force from 42 and after its passage.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT TO AMEND SECTION 25-3-73, MISSISSIPPI CODE OF 1972, TO 2DELAY THE IMPLEMENTATION DATE WHEREBY CERTAIN STATE AND NONSTATE 3 SERVICE EMPLOYEES SHALL BE PAID ON A DELAYED BASIS TWICE A MONTH, 4 AND TO EXEMPT EMPLOYEES OF THE STATE INSTITUTIONS OF HIGHER 5 LEARNING FROM THE DELAYED BASIS PAYMENT REQUIREMENT; TO AUTHORIZE 6 CERTAIN PAYROLL DEDUCTIONS FROM THE SALARIES OF STATE EMPLOYEES; 7 AND FOR RELATED PURPOSES.
