AMENDMENT No. 1 PROPOSED TO**

**Senate Bill NO. 3273**

5       Amend by striking all after the enacting clause and inserting  
6 in lieu thereof the following:

8       SECTION 1. That the following sum, or so much thereof as may  
9 be necessary, is hereby appropriated out of any money in the State  
10 General Fund not otherwise appropriated, to the Board of Trustees  
11 of State Institutions of Higher Learning for the purpose of paying  
12 the expenses incurred in the operation and maintenance of the  
13 Forest and Wildlife Research Center for the fiscal year beginning  
14 July 1, 2000, and ending June 30, 2001.....  
15 .....\$           5,682,189.00.

16       SECTION 2. The following sum, or so much thereof as may be  
17 necessary, is hereby authorized for expenditure out of any special  
18 source funds which are collected by or otherwise become available  
19 for the purpose of defraying the expenses of the Forest and  
20 Wildlife Research Center, for the fiscal year beginning  
21 July 1, 2000, and ending June 30, 2001.....\$           1,186,646.00.

22       SECTION 3. No general funds authorized to be expended herein  
23 shall be used to replace federal funds and/or other special funds  
24 which are being used for salaries authorized under the provisions  
25 of this act and which are withdrawn and no longer available.

26       SECTION 4. It is the intent of the Legislature that if the  
27 funds appropriated in Section 1 of this act are used directly or

28 indirectly to match or otherwise secure any federal grants,  
29 research grants or donations, such special source funds not  
30 classified as restricted funds shall be added and accounted for  
31 under Section 2 of this act. Further, it is the intention of the  
32 Legislature that all such aforementioned special source funds be  
33 included in all reports and requests for the 2001 Regular Session  
34 of the Mississippi Legislature.

35 SECTION 5. It is the intention of the Legislature that the  
36 agency's budget request for fiscal year 2002 shall be submitted to  
37 the Joint Legislative Budget Committee in a format and level of  
38 detail comparable to the format and level of detail provided  
39 during the fiscal year 2001 budget request process.

40 SECTION 6. Of the funds appropriated in Section 2, the  
41 following amounts shall be derived from the Education Enhancement  
42 Fund as follows:

43 (a) Three Hundred Thirty-nine Thousand One Hundred Fifty-  
44 one Dollars (\$339,151.00) shall be derived from  
45 funds deposited pursuant to Sections 27-65-75 and  
46 27-67-31, Mississippi Code of 1972.

47 (b) Seventy-nine Thousand Four Hundred Ninety-five  
48 Dollars (\$79,495.00) shall be derived from  
49 funds deposited pursuant to Section 27-103-203(1),  
50 Mississippi Code of 1972.

51 SECTION 7. Should revenues generated and deposited to the  
52 Education Enhancement Fund pursuant to Section 27-103-203(1),  
53 Mississippi Code of 1972, fall below funds appropriated herein  
54 from said source, the Board of Trustees of State Institutions of  
55 Higher Learning shall notify the Department of Finance and  
56 Administration as to which allotments shall be reduced to insure  
57 that expenditures do not exceed actual revenues.

58 SECTION 8. The money herein appropriated shall be paid by  
59 the State Treasurer out of any money in the State Treasury to the  
60 credit of the proper fund or funds as set forth in this act, upon  
61 warrants issued by the State Fiscal Officer; and the State Fiscal  
62 Officer shall issue his warrants upon requisitions signed by the

63proper person, officer or officers, in the manner provided by law.

64 SECTION 9. This act shall take effect and be in force from

65and after July 1, 2000.
