AMENDMENT No. 1 PROPOSED TO**

House Bill NO. 1643

5 Amend by striking all after the enacting clause and inserting
6 in lieu thereof the following:

8 SECTION 1. The following sum, or so much thereof as may be
9 necessary, is hereby appropriated out of any money in the State
10 Treasury to the credit of the Mississippi Athletic Commission
11 Fund, for the purpose of defraying the expenses of the Mississippi
12 Athletic Commission for the fiscal year beginning July 1, 2000,
13 and ending June 30, 2001\$ 110,000.00.

14 SECTION 2. With the funds approved for expenditure under
15 Section 1, the following positions are authorized:

21 With the funds herein appropriated, it is the intention of
22 the Legislature that it shall be the agency's responsibility to
23 make certain that funds required to be appropriated for "Personal
24 Services" for Fiscal Year 2002 do not exceed Fiscal Year 2001
25 funds appropriated for that purpose, unless programs or positions
26 are added to the agency's Fiscal Year 2002 budget by the
27 Mississippi Legislature. Based on data provided by the

28Legislative Budget Office, the State Personnel Board shall
29determine and publish the projected annual cost to fully fund all
30appropriated positions in compliance with the provisions of this
31act. It shall be the responsibility of the agency head to insure
32that no single personnel action increases this projected annual
33cost and/or the Fiscal Year 2001 appropriation for "Personal
34Services" when annualized. If, at the end of any calendar month,
35the State Personnel Board determines that the agency has taken
36action(s) which would cause the agency to exceed this projected
37annual cost or the Fiscal Year 2001 "Personal Services"
38appropriated level, when annualized, then only those actions which
39reduce the projected annual cost and/or the appropriation
40requirement will be processed by the State Personnel Board until
41such time as the requirements of this provision are met.

42 Any transfers or escalations shall be made in accordance with
43the terms, conditions and procedures established by law.

44 No general funds authorized to be expended herein shall be
45used to replace federal funds and/or other special funds which are
46being used for salaries authorized under the provisions of this
47act and which are withdrawn and no longer available.

48 SECTION 3. The money herein appropriated shall be paid by
49the State Treasurer out of any money in the State Treasury to the
50credit of the proper fund or funds as set forth in this act, upon
51warrants issued by the State Fiscal Officer; and the State Fiscal
52Officer shall issue his warrants upon requisitions signed by the
53proper person, officer or officers in the manner provided by law.

54 SECTION 4. This act shall take effect and be in force from
55and after July 1, 2000.
