## SENATE CONCURRENT RESOLUTION NO. 501

1 A CONCURRENT RESOLUTION COMMENDING WALTER BOOKER UPON HIS 2 RETIREMENT AS SUPERINTENDENT OF THE MISSISSIPPI STATE PENITENTIARY 3 AND EXPRESSING THE THANKS OF THE LEGISLATURE FOR HIS MANY YEARS OF DEDICATED STATE SERVICE. 5 WHEREAS, on August 27, 2000, Walter Booker will retire as Superintendent of the Mississippi State Penitentiary following a 6 7 30-year career in the field of corrections and social service; and WHEREAS, in July of 1997, Superintendent Booker was appointed 8 Superintendent of the Mississippi State Penitentiary, the position 9 10 in which he currently serves; the Mississippi State Penitentiary encompasses approximately 15,000 acres of land, has an inmate 11 population capacity of 5,700, a security and support staff of 12 approximately 2,000 and an annual budget of \$80,000,000.00; and 13 WHEREAS, the Mississippi State Penitentiary is the largest 14 15 prison in the State of Mississippi and has been designated the Maximum Security Prison of the state and during the last year, 16 17 Superintendent Booker has been working diligently to get the 97-year old institution ready for ACA Accreditation and to 18 standardize job classifications within the department; and 19 20 WHEREAS, Walter Booker was born in Bobo, Mississippi, and graduated from Mississippi Valley State University in 1971, with a 21 22 Bachelor Degree in Social Science and a minor in Sociology; he also did graduate work at Delta State University; and 23 24 WHEREAS, Superintendent Booker began his post-college 25 professional career as a Social Worker for the Coahoma County, 26 Mississippi, Early Childhood Development Program, where he was promoted to Director of Social Services within a year of his 27

- 28 employment with that agency; and
- 29 WHEREAS, Superintendent Booker began his career with the
- 30 Mississippi Department of Corrections as the Assistant Director of
- 31 the Job Placement Center for incarcerated offenders, where he was
- 32 assigned for three years; from 1981 to 1988, Superintendent Booker
- 33 served as Unit Case Manager and Case Manager Supervisor; in
- 34 September of 1988, Superintendent Booker was promoted to warden of
- 35 a sub-area of the Mississippi State Penitentiary, which housed
- 36 death row inmates, maximum security and medium custody inmates;
- 37 for the next 7-1/2 years, Superintendent Booker served as warden
- 38 of every sub-area of the Mississippi State Penitentiary; although
- 39 Superintendent Booker was warden over high security risk inmates,
- 40 in a period of 7-1/2 years only one inmate escaped from his area
- 41 of responsibility; in 1995, Superintendent Booker was assigned to
- 42 the position of Warden of Treatment Services at the Mississippi
- 43 State Penitentiary and served in this capacity until January of
- 44 1997; while serving as Warden of Treatment Services,
- 45 Superintendent Booker was instrumental in initiating the Alcohol
- 46 and Drug Therapeutic Community at the Mississippi State
- 47 Penitentiary; in January of 1997, Superintendent Booker was
- 48 assigned to the position of Warden/Chief of Security of the
- 49 Mississippi State Penitentiary where he served until July of 1997;
- 50 and
- 51 WHEREAS, he is a former member of the Clarksdale, Coahoma
- 52 County Junior Chamber of Commerce; former President of the Coahoma
- 53 County Headstart Parent Association; former Vice President of the
- 54 Mississippi Headstart Parent Association; current member of the
- 55 Mississippi Association of Professionals in Corrections; provided
- 56 the leadership to the United Way and Muscular Dystrophy
- 57 Associations and is a veteran of the United States Army obtaining
- 58 the rank of Sergeant E5; and
- 59 WHEREAS, it is with great pride that we recognize the
- 60 outstanding and dedicated professional service and civic
- 61 accomplishments of this Mississippian:
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
- 63 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
- 64 we do hereby commend Walter Booker upon his retirement as

- 65 Superintendent of the Mississippi State Penitentiary at Parchman,
- 66 Mississippi, express the thanks of the Legislature for his many
- 67 years of dedicated state service and wish Walter and his family
- 68 continued success in his future endeavors:
- BE IT FURTHER RESOLVED, That a copy of this resolution be
- 70 presented to Mr. Walter Booker and his family and be made
- 71 available to the Commissioner of the Mississippi Department of
- 72 Corrections and the Capitol Press Corps.
