## HOUSE BILL NO. 323

AN ACT TO AMEND SECTION 37-101-15, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT FOR THE PERIOD BEGINNING WITH THE STATE FISCAL 3 YEAR 2003 AND ENDING WITH THE STATE FISCAL YEAR 2012, THE BOARD OF TRUSTEES OF STATE INSTITUTIONS OF HIGHER LEARNING SHALL PREPARE THE ANNUAL BUDGETS FOR THE INSTITUTIONS OF HIGHER LEARNING IN SUCH A MANNER TO PROVIDE THE LARGEST BUDGET FOR THE INSTITUTION OF 6 7 HIGHER LEARNING WITH THE LOWEST STUDENT ENROLLMENT FOR THE PREVIOUS SCHOOL YEAR AND TO PROVIDE THE SMALLEST BUDGET FOR THE INSTITUTION OF HIGHER LEARNING WITH THE HIGHEST STUDENT ENROLLMENT 8 9 10 FOR THE PREVIOUS SCHOOL YEAR; TO PROVIDE THAT DURING SUCH PERIOD, EACH INSTITUTION OF HIGHER LEARNING SHALL SUBMIT AN ANNUAL PLAN TO 11 THE BOARD OF TRUSTEES INDICATING HOW THE INSTITUTION OF HIGHER 12 LEARNING WILL USE THE FUNDS ALLOCATED TO IT; AND FOR RELATED 13 14 PURPOSES.

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- SECTION 1. Section 37-101-15, Mississippi Code of 1972, is
- 17 amended as follows:
- 18 37-101-15. (a) The Board of Trustees of State Institutions
- 19 of Higher Learning shall succeed to and continue to exercise
- 20 control of all records, books, papers, equipment, and supplies,
- 21 and all lands, buildings, and other real and personal property
- 22 belonging to or assigned to the use and benefit of the board of
- 23 trustees formerly supervising and controlling the institutions of
- 24 higher learning named in Section 37-101-1. The board shall have
- 25 and exercise control of the use, distribution and disbursement of
- 26 all funds, appropriations and taxes, now and hereafter in
- 27 possession, levied and collected, received, or appropriated for
- 28 the use, benefit, support, and maintenance or capital outlay
- 29 expenditures of the institutions of higher learning, including the
- 30 authorization of employees to sign vouchers for the disbursement
- 31 of funds for the various institutions, except where otherwise
- 32 specifically provided by law.

The board shall have general supervision of the affairs 33 of all the institutions of higher learning, including the 34 departments and the schools thereof. The board shall have the 35 power in its discretion to determine who shall be privileged to 36 37 enter, to remain in, or to graduate therefrom. The board shall have general supervision of the conduct of libraries and 38 laboratories, the care of dormitories, buildings, and grounds; the 39 business methods and arrangement of accounts and records; the 40 organization of the administrative plan of each institution; and 41 all other matters incident to the proper functioning of the 42 43 The board shall have the authority to establish minimum standards of achievement as a prerequisite for entrance 44 45 into any of the institutions under its jurisdiction, which standards need not be uniform between the various institutions and 46 47 which may be based upon such criteria as the board may establish. (C) The board shall exercise all the powers and prerogatives 48 49 conferred upon it under the laws establishing and providing for 50 the operation of the several institutions herein specified. board shall adopt such bylaws and regulations from time to time as 51 52 it deems expedient for the proper supervision and control of the several institutions of higher learning, insofar as such bylaws 53 54 and regulations are not repugnant to the Constitution and laws, and not inconsistent with the object for which these institutions 55 were established. The board shall have power and authority to 56

buildings of the respective institutions, to authorize the arrest

(d) For all institutions specified herein, the board shall provide a uniform system of recording and of accounting approved by the State Department of Audit. The board shall annually prepare, or cause to be prepared, a budget for each institution of

higher learning for the succeeding year which must be prepared and 66 in readiness for at least thirty (30) days before the convening of 67 the regular session of the Legislature. For the period beginning 68 69 with the state fiscal year 2003 and ending with the state fiscal 70 year 2012, the board shall prepare, or cause to be prepared, the 71 budgets in such a manner to provide the largest budget for the institution of higher learning with the lowest student enrollment 72 for the previous school year and to provide the smallest budget 73 for the institution of higher learning with the highest student 74 enrollment for the previous school year. During such period, each 75 76 institution of higher learning shall submit an annual plan to the board indicating how the institution of higher learning will use 77 78 the funds allocated to it. All relationships and negotiations between the state Legislature and its various committees and the 79 institutions named herein shall be carried on through the board of 80 trustees. No official, employee or agent representing any of the 81 separate institutions shall appear before the Legislature or any 82 committee thereof except upon the written order of the board or 83 upon the request of the Legislature or a committee thereof. 84 85 For all institutions specified herein, the board shall prepare an annual report to the Legislature setting forth the 86 87 disbursements of all monies appropriated to the respective institutions. Each report to the Legislature shall show how the 88 money appropriated to the several institutions has been expended, 89 90 beginning and ending with the fiscal years of the institutions, showing the name of each teacher, officer, and employee, and the 91 92 salary paid each, and an itemized statement of each and every item of receipts and expenditures. Each report must be balanced, and 93 must begin with the former balance. If any property belonging to 94 the state or the institution is used for profit, the reports shall 95 96 show the expense incurred in managing the property and the amount 97 received therefrom. The reports shall also show a summary of the gross receipts and gross disbursements for each year and shall 98 H. B. No.

show the money on hand at the beginning of the fiscal period of 99 the institution next preceding each session of the Legislature and 100 the necessary amount of expense to be incurred from said date to 101 102 January 1 following. The board shall keep the annual expenditures 103 of each institution herein mentioned within the income derived from legislative appropriations and other sources, but in case of 104 emergency arising from acts of providence, epidemics, fire or 105 106 storm with the written approval of the Governor and by written 107 consent of a majority of the Senators and of the Representatives it may exceed the income. The board shall require a surety bond 108 109 in a surety company authorized to do business in this state, of every employee who is the custodian of funds belonging to one or 110 111 more of the institutions mentioned herein, which bond shall be in a sum to be fixed by the board in an amount that will properly 112 safeguard the said funds, the premium for which shall be paid out 113 of the funds appropriated for said institutions. 114

The board shall have the power and authority to elect the heads of the various institutions of higher learning and to contract with all deans, professors, and other members of the teaching staff, and all administrative employees of said institutions for a term of not exceeding four (4) years. board shall have the power and authority to terminate any such contract at any time for malfeasance, inefficiency, or contumacious conduct, but never for political reasons. It shall be the policy of the board to permit the executive head of each institution to nominate for election by the board all subordinate employees of the institution over which he presides. It shall be the policy of the board to elect all officials for a definite tenure of service and to reelect during the period of satisfactory The board shall have the power to make any adjustments service. it thinks necessary between the various departments and schools of

any institution or between the different institutions.

(h) The board shall have the power to contract, on a shared-savings, lease or lease-purchase basis, for energy efficiency services and/or equipment as prescribed in Section

31-7-14, not to exceed ten (10) years.

(i) The Board of Trustees of State Institutions of Higher
Learning, for and on behalf of Jackson State University, is hereby
authorized to convey by donation or otherwise easements across
portions of certain real estate located in the City of Jackson,
Hinds County, Mississippi, for right-of-way required for the Metro
Parkway Project.

SECTION 2. This act shall take effect and be in force from and after July 1, 2001.
