## HOUSE BILL NO. 573

AN ACT TO AMEND SECTION 47-5-935, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT ANY SHERIFF THAT CONTRACTS TO PROVIDE ADDITIONAL 3 MANAGEMENT SUPPORT FOR A REGIONAL CORRECTIONAL FACILITY SHALL RECEIVE ADDITIONAL COMPENSATION EQUAL TO TWENTY-FIVE PERCENT OF THE AMOUNT PAID TO THE CHIEF CORRECTIONS OFFICER; TO AMEND SECTION  $47\text{-}5\text{-}937\text{, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT THE COUNTY OR COUNTIES CONTRACTING FOR A REGIONAL CORRECTIONAL FACILITY SHALL$ 6 7 PROVIDE THE LAW ENFORCEMENT PERSONNEL THAT ARE NEEDED TO STAFF THE 8 FACILITY; TO AMEND SECTION 25-3-25, MISSISSIPPI CODE OF 1972, IN 9 CONFORMITY WITH THE PROVISIONS OF THIS ACT; AND FOR RELATED 10 PURPOSES. 11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 12 SECTION 1. Section 47-5-935, Mississippi Code of 1972, is 13 14 amended as follows:

- 47-5-935. Concurrent with the execution of a contract for 15
- 16 housing of state offenders as authorized by Sections 47-5-931
- 17 through 47-5-941, the sheriff of a county where the facility is
- located is designated as the Chief Corrections Officer for the 18
- facility housing state offenders, and in that capacity, shall 19
- assume responsibility for management of the corrections facility 20
- and for the provision of the care and control of the state 21
- offenders housed therein. The sheriff shall be subject to the 22
- direction of the department for management of the correctional 23
- facility. In addition to the compensation provided by Section 24
- 25 25-3-25, the sheriff shall receive Fifteen Thousand Six Hundred
- Dollars (\$15,600.00) as compensation for the duties specified in 26
- Sections 47-5-931 through 47-5-941. If the Chief Corrections 27
- Officer for a correctional facility created under Section 28
- 47-5-931, contracts with a sheriff of another county to provide 29
- 30 additional management support for the facility, then the sheriff
- who is providing the additional support for the facility shall 31

- 32 receive, in addition to the compensation provided by Section
- 33 25-3-25, a yearly amount equal to twenty-five percent (25%) of the
- 34 pay authorized in this section for the Chief Corrections Officer.
- 35 SECTION 2. Section 47-5-937, Mississippi Code of 1972, is
- 36 amended as follows:
- 37 47-5-937. Sections 47-5-931 through 47-5-941 shall be full
- 38 and complete authority for the exercise of all powers and
- 39 authority granted herein and no requirements or restrictions of
- 40 law which would otherwise be applicable to acts of the county or
- 41 sheriff or the Department of Corrections shall be applicable
- 42 except as expressly provided herein. The sheriff is expressly
- 43 authorized to employ counsel to represent the facility to be paid
- 44 a salary within the range allowed for a legal assistant to a
- 45 district attorney with the employment to continue for a period of
- 46 time not to exceed the duration of the indebtedness incurred for
- 47 construction of the facility. The county or counties shall pay
- 48 this cost and other costs incurred in the operation of the
- 49 facility from the proceeds of the funds derived from the financing
- 50 of the project and the housing of offenders. The county or
- 51 counties also shall supply all law enforcement personnel that are
- 52 needed to staff a facility created under Sections 47-5-931 through
- 53 <u>47-5-941.</u>
- SECTION 3. Section 25-3-25, Mississippi Code of 1972, is
- 55 amended as follows:
- 56 25-3-25. (1) Except as otherwise provided in subsections
- 57 (2) through (9) of this section and Section 47-5-935, the salaries
- 58 of sheriffs of the various counties are hereby fixed as full
- 59 compensation for their services.
- From and after October 1, 1998, the annual salary for each
- 61 sheriff shall be based upon the total population of his county
- 62 according to the latest federal decennial census in the following
- 63 categories and for the following amounts; however, no sheriff
- 64 shall be paid less than the salary authorized under this section

- 65 to be paid the sheriff based upon the population of the county
- 66 according to the 1980 federal decennial census:
- 67 (a) For counties with a total population of more than
- 68 two hundred thousand (200,000), a salary of Seventy-five Thousand
- 69 Dollars (\$75,000.00).
- 70 (b) For counties with a total population of more than
- 71 one hundred thousand (100,000) and not more than two hundred
- 72 thousand (200,000), a salary of Seventy Thousand Dollars
- 73 (\$70,000.00).
- 74 (c) For counties with a total population of more than
- 75 forty-five thousand (45,000) and not more than one hundred
- 76 thousand (100,000), a salary of Sixty-five Thousand Dollars
- 77 (\$65,000.00).
- 78 (d) For counties with a total population of more than
- 79 thirty-four thousand (34,000) and not more than forty-five
- 80 thousand (45,000), a salary of Sixty Thousand Dollars
- 81 (\$60,000.00).
- 82 (e) For counties with a total population of more than
- 83 twenty-five thousand (25,000) and not more than thirty-four
- 84 thousand (34,000), a salary of Fifty-two Thousand Dollars
- 85 (\$52,000.00).
- 86 (f) For counties with a total population of more than
- 87 fifteen thousand (15,000) and not more than twenty-five thousand
- 88 (25,000), a salary of Fifty Thousand Dollars (\$50,000.00).
- 89 (g) For counties with a total population of more than
- 90 nine thousand five hundred (9,500) and not more than fifteen
- 91 thousand (15,000), a salary of Forty-seven Thousand Dollars
- 92 (\$47,000.00).
- 93 (h) For counties with a total population of more than
- 94 seven thousand five hundred (7,500) and not more than nine
- 95 thousand five hundred (9,500), a salary of Forty-five Thousand
- 96 Dollars (\$45,000.00).

- 98 than seven thousand five hundred (7,500), a salary of Forty-two
- 99 Thousand Dollars (\$42,000.00).
- 100 (2) In addition to the salary provided for in subsection (1)
- 101 of this section, the Board of Supervisors of Leflore County may,
- 102 in its discretion, pay an annual supplement to the sheriff of the
- 103 county in an amount not to exceed Ten Thousand Dollars
- 104 (\$10,000.00). The Legislature finds and declares that the annual
- 105 supplement authorized by this subsection is justified in such
- 106 county for the following reasons:
- 107 (a) The Mississippi Department of Corrections operates
- 108 and maintains a restitution center within the county;
- 109 (b) The Mississippi Department of Corrections operates
- 110 and maintains a community work center within the county;
- 111 (c) There is a resident circuit court judge in the
- 112 county whose office is located at the Leflore County Courthouse;
- 113 (d) There is a resident chancery court judge in the
- 114 county whose office is located at the Leflore County Courthouse;
- (e) The Magistrate for the Fourth Circuit Court
- 116 District is located in the county and maintains his office at the
- 117 Leflore County Courthouse;
- 118 (f) The Region VI Mental Health-Mental Retardation
- 119 Center, which serves a multicounty area, calls upon the sheriff to
- 120 provide security for out-of-town mental patients, as well as
- 121 patients from within the county;
- 122 (g) The increased activity of the Child Support
- 123 Division of the Department of Human Services in enforcing in the
- 124 courts parental obligations has imposed additional duties on the
- 125 sheriff; and
- 126 (h) The dispatchers of the enhanced E-911 system in
- 127 place in Leflore County has been placed under the direction and
- 128 control of the sheriff.

- (e) The State Fire Academy is operated and maintained
- 147 within the county;
- 148 (f) The Pearl River Valley Water Supply District,
- 149 ordinarily known as the "Reservoir District," is located within
- 150 the county;
- 151 (g) The Jackson International Airport is located within
- 152 the county;
- (h) The patrolling of the state properties located
- 154 within the county has imposed additional duties on the sheriff;
- 155 and
- 156 (i) The sheriff, in addition to providing security to
- 157 the nearly one hundred thousand (100,000) residents of the county,
- 158 has the duty to investigate, solve and assist in the prosecution
- 159 of any misdemeanor or felony committed upon any state property
- 160 located in Rankin County.



- 161 (4) In addition to the salary provided for in subsection (1)
  162 of this section, the Board of Supervisors of Neshoba County shall
  163 pay an annual supplement to the sheriff of the county an amount
- 164 equal to Ten Thousand Dollars (\$10,000.00).
- 165 (5) In addition to the salary provided for in subsection (1)
- 166 of this section, the Board of Supervisors of Tunica County may, in
- 167 their discretion, pay an annual supplement to the sheriff of the
- 168 county an amount equal to Ten Thousand Dollars (\$10,000.00),
- 169 payable beginning April 1, 1997.
- 170 (6) In addition to the salary provided for in subsection (1)
- 171 of this section, the Board of Supervisors of Hinds County shall
- 172 pay an annual supplement to the sheriff of the county in an amount
- equal to Fifteen Thousand Dollars (\$15,000.00). The Legislature
- 174 finds and declares that the annual supplement authorized by this
- 175 subsection is justified in such county for the following reasons:
- 176 (a) Hinds County has the greatest population of any
- 177 county, two hundred fifty-four thousand four hundred forty-one
- 178 (254,441) by the 1990 census, being almost one hundred thousand
- 179 (100,000) more than the next most populous county;
- 180 (b) Hinds County is home to the state capitol and the
- 181 seat of all state government offices;
- 182 (c) Hinds County is the third largest county in
- 183 geographic area, containing eight hundred seventy-five (875)
- 184 square miles;
- (d) Hinds County is comprised of two (2) judicial
- 186 districts, each having a courthouse and county office buildings;
- 187 (e) There are four (4) resident circuit judges, four
- 188 (4) resident chancery judges, and three (3) resident county judges
- 189 in Hinds County, the most of any county, with the sheriff acting
- 190 as chief executive officer and provider of bailiff services for
- 191 all;
- 192 (f) The main offices for the clerk and most of the
- 193 judges and magistrates for the United States District Court for

- 194 the Southern District of Mississippi are located within the
- 195 county;
- 196 (g) The state's only urban university, Jackson State
- 197 University, is located within the county;
- 198 (h) The University of Mississippi Medical Center,
- 199 combining the medical school, dental school, nursing school and
- 200 hospital, is located within the county;
- 201 (i) Mississippi Veterans Memorial Stadium, the state's
- 202 largest sports arena, is located within the county;
- 203 (j) The Mississippi State Fairgrounds, including the
- 204 Coliseum and Trade Mart, are located within the county;
- 205 (k) Hinds County has the largest criminal population in
- 206 the state, such that the Hinds County Sheriff's Department
- 207 operates the largest county jail system in the state, housing
- 208 almost one thousand (1,000) inmates in three (3) separate
- 209 detention facilities;
- 210 (1) The Hinds County Sheriff's Department handles more
- 211 mental and drug and alcohol commitments cases than any other
- 212 sheriff's department in the state;
- 213 (m) The Mississippi Department of Corrections maintains
- 214 a restitution center within the county;
- 215 (n) The Mississippi Department of Corrections regularly
- 216 houses as many as one hundred (100) state convicts within the
- 217 Hinds County jail system; and
- 218 (o) The Hinds County Sheriff's Department is regularly
- 219 asked to provide security services not only at the Fairgrounds and
- 220 Memorial Stadium, but also for events at the Mississippi Museum of
- 221 Art and Jackson City Auditorium.
- 222 (7) In addition to the salary provided for in subsection (1)
- 223 of this section, the Board of Supervisors of Wilkinson County, in
- 224 its discretion, may pay an annual supplement to the sheriff of the
- 225 county in an amount not to exceed Ten Thousand Dollars

226 (\$10,000.00). The Legislature finds and declares that the annual

- 227 supplement authorized by this subsection is justified in such
- 228 county because the Mississippi Department of Corrections contracts
- 229 for the private incarceration of state inmates at a private
- 230 correctional facility within the county.
- 231 (8) In addition to the salary provided for in subsection (1)
- 232 of this section, the Board of Supervisors of Marshall County, in
- 233 its discretion, may pay an annual supplement to the sheriff of the
- 234 county in an amount not to exceed Ten Thousand Dollars
- 235 (\$10,000.00). The Legislature finds and declares that the annual
- 236 supplement authorized by this subsection is justified in such
- 237 county because the Mississippi Department of Corrections contracts
- 238 for the private incarceration of state inmates at a private
- 239 correctional facility within the county.
- 240 (9) In addition to the salary provided in subsection (1) of
- 241 this section, the Board of Supervisors of Greene County, in its
- 242 discretion, may pay an annual supplement to the sheriff of the
- 243 county in an amount not to exceed Ten Thousand Dollars
- 244 (\$10,000.00). The Legislature finds and declares that the annual
- 245 supplement authorized by this subsection is justified in such
- 246 county for the following reasons:
- 247 (a) The Mississippi Department of Corrections operates
- 248 and maintains the South Mississippi Correctional Facility within
- 249 the county;
- 250 (b) In 1996, additional facilities to house another one
- 251 thousand four hundred sixteen (1,416) male offenders were
- 252 constructed at the South Mississippi Correctional Facility within
- 253 the county; and
- 254 (c) The patrolling of the state properties located
- 255 within the county has imposed additional duties on the sheriff
- 256 justifying additional compensation.
- 257 (10) The salaries herein provided shall be payable monthly
- 258 on the first day of each calendar month by chancery clerk's
- 259 warrant drawn on the general fund of the county; however, the

- 260 board of supervisors, by resolution duly adopted and entered on
- 261 its minutes, may provide that such salaries shall be paid
- 262 semimonthly on the first and fifteenth day of each month. If a
- 263 pay date falls on a weekend or legal holiday, salary payments
- 264 shall be made on the workday immediately preceding the weekend or
- 265 legal holiday.
- SECTION 4. This act shall take effect and be in force from
- 267 and after July 1, 2001.
