HOUSE BILL NO. 592

AN ACT TO AMEND SECTION 97-37-1, MISSISSIPPI CODE OF 1972, TO
PROVIDE THAT IT SHALL BE A FELONY FOR THE ILLEGAL CARRYING OF A
DEADLY WEAPON IF THE OFFENSE OCCURS ON ANY PREMISES LICENSED TO
SELL OR SERVE ALCOHOLIC BEVERAGES, BEER OR LIGHT WINE AND TO
PROVIDE PENALTIES THEREFOR; AND FOR RELATED PURPOSES.
BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
SECTION 1. Section 97-37-1, Mississippi Code of 1972, is

8 amended as follows:

97-37-1. (1) Except as otherwise provided in Section 9 45-9-101, any person who carries, concealed in whole or in part, 10 any bowie knife, dirk knife, butcher knife, switchblade knife, 11 metallic knuckles, blackjack, slingshot, pistol, revolver, or any 12 rifle with a barrel of less than sixteen (16) inches in length, or 13 14 any shotqun with a barrel of less than eighteen (18) inches in length, machine gun or any fully automatic firearm or deadly 15 weapon, or any muffler or silencer for any firearm, whether or not 16 it is accompanied by a firearm, or uses or attempts to use against 17 another person any imitation firearm, shall upon conviction be 18 19 punished as follows:

(a) By a fine of not less than One Hundred Dollars
(\$100.00) nor more than Five Hundred Dollars (\$500.00), or by
imprisonment in the county jail for not more than six (6) months,
or both, in the discretion of the court, for the first conviction
under this section.

(b) By a fine of not less than One Hundred Dollars
(\$100.00) nor more than Five Hundred Dollars (\$500.00), and
imprisonment in the county jail for not less than thirty (30) days

nor more than six (6) months, for the second conviction under this 28 29 section.

By imprisonment in the State Penitentiary for not 30 (C) less than one (1) year nor more than five (5) years, for the third 31 32 or more convictions under this section.

33 (d) By imprisonment in the State Penitentiary for not less than one (1) year nor more than five (5) years for any person 34 previously convicted of any felony who is convicted under this 35 section. 36

By imprisonment in the State Penitentiary for not 37 (e) less than two (2) years, nor more than ten (10) years, and by a 38 fine not to exceed Five Thousand Dollars (\$5,000.00), for any 39 40 person convicted under this section if the offense occurs on any premises licensed or issued a permit under Title 67, Mississippi 41 Code of 1972, for the sale or service of alcoholic beverages, beer 42 or light wine. A violation of this paragraph shall be a felony. 43

(2) It shall not be a violation of this section for any 44 person over the age of eighteen (18) years to carry a firearm or 45 deadly weapon concealed in whole or in part within the confines of 46 47 his own home or his place of business, or any real property associated with his home or business or within any motor vehicle. 48

49 (3) It shall not be a violation of this section for any person to carry a firearm or deadly weapon concealed in whole or 50 in part if the possessor of the weapon is then engaged in a 51 52 legitimate weapon-related sports activity or is going to or returning from such activity. For purposes of this subsection, 53 "legitimate weapon-related sports activity" means hunting, 54 fishing, target shooting or any other legal sports activity which 55 normally involves the use of a firearm or other weapon. 56 57 SECTION 2. This act shall take effect and be in force from

58 and after its passage.
