HOUSE BILL NO. 723

1 AN ACT MAKING A REAPPROPRIATION TO THE DEPARTMENT OF FINANCE  
2 AND ADMINISTRATION TO REAUTHORIZE THE EXPENDITURE OF STATE GENERAL  
3 FUNDS AND SPECIAL FUNDS PREVIOUSLY APPROPRIATED FOR CONSTRUCTION  
4 AND/OR REPAIR AND RENOVATION PROJECTS AT VARIOUS STATE AGENCIES  
5 AND INSTITUTIONS, FOR FISCAL YEAR 2002.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 SECTION 1. The following sum, or so much thereof as may be  
8 necessary, is hereby reappropriated out of any money in the State  
9 General Fund not otherwise appropriated, to the Department of  
10 Finance and Administration, acting through the Bureau of Building,  
11 Grounds and Real Property Management, for the purpose of  
12 reauthorizing the expenditure of State General Funds, as  
13 authorized in Senate Bill No. 3199, Regular Session of 1995,  
14 Senate Bill No. 2503, Regular Session of 1996, Senate Bill No.  
15 2427, Regular Session of 1997, House Bill No. 1684, Regular  
16 Session of 1998, House Bill No. 1331, Regular Session of 1999, and  
17 House Bill 834, Regular Session of 2000, for the fiscal year  
18 beginning July 1, 2001, and ending June 30, 2002.....  
19 ..... \$ 66,550.00

20 This reappropriation is made for the purpose of reauthorizing  
21 the expenditure of State General Funds for renovating and/or  
22 repairing existing state-owned facilities and for purchasing  
23 and/or replacing furniture and equipment for all institutions,  
24 agencies and departments of the State of Mississippi.

25 Notwithstanding the amount reappropriated under the  
26 provisions of this section, in no event shall the amount expended  
27 exceed the unexpended balance as of June 30, 2001, or change the  
28 purpose for which the funds were originally authorized.



29 SECTION 2. The following sum, or so much thereof as may be  
30 necessary, is hereby reappropriated out of any money in the State  
31 Treasury to the credit of Fund No. 3931, to the Department of  
32 Finance and Administration, acting through the Bureau of Building,  
33 Grounds and Real Property Management, for the purpose of  
34 reauthorizing the expenditure of funds previously appropriated for  
35 construction and/or repair and renovation projects at various  
36 state agencies and institutions, for the fiscal year beginning  
37 July 1, 2001, and ending June 30, 2002.....  
38 ..... \$ 33,984,400.00.

39 This reappropriation is made for the purpose of reauthorizing  
40 the expenditure of special funds for construction and/or repair  
41 and renovation projects at various state agencies and institutions  
42 that had been authorized by the Legislature in prior fiscal years.

43 Notwithstanding the amount reappropriated under the  
44 provisions of this section, in no event shall the amount expended  
45 exceed the unexpended balance as of June 30, 2001, or change the  
46 purpose for which the funds were originally authorized.

47 SECTION 3. The following sum, or so much thereof as may be  
48 necessary, is hereby reappropriated out of any money in the State  
49 Treasury to the credit of the Education Enhancement Fund No. 4900,  
50 to the Department of Finance and Administration, acting through  
51 the Bureau of Building, Grounds and Real Property Management, for  
52 the purpose of reauthorizing the expenditure of funds previously  
53 appropriated for construction and/or repair and renovation  
54 projects at various state agencies and institutions, for the  
55 fiscal year beginning July 1, 2001, and ending June 30, 2002  
56 ..... \$ 392,305.00

57 This reappropriation is made for the purpose of reauthorizing  
58 the expenditure of special funds for construction and/or repair  
59 and renovation projects at various state agencies and institutions  
60 that had been authorized by the Legislature in prior fiscal years.



61           Notwithstanding the amount reappropriated under the  
62 provisions of this section, in no event shall the amount expended  
63 exceed the unexpended balance as of June 30, 2001 or change the  
64 purpose for which the funds were originally authorized.

65           SECTION 4. The Bureau of Building, Grounds and Real Property  
66 Management of the Office of General Services is hereby expressly  
67 authorized and empowered to receive, budget and expend any state,  
68 local or other source funds designated for supplemental funding of  
69 construction and/or repair and renovation projects.

70           SECTION 5. The money herein appropriated shall be paid by  
71 the State Treasurer out of any money in the State Treasury to the  
72 credit of the proper fund or funds as set forth in this act, upon  
73 warrants issued by the State Fiscal Officer; and the State Fiscal  
74 Officer shall issue his warrants upon requisitions signed by the  
75 proper person, officer or officers, in the manner provided by law.

76           SECTION 6. This act shall take effect and be in force from  
77 and after July 1, 2001.
