1	AN ACT TO AMEND SECTION 23-15-295, MISSISSIPPI CODE OF 1972,
2	TO PROVIDE THAT IF AFTER THE QUALIFYING DEADLINE, BUT BEFORE THE
3	PRIMARY ELECTION, THE SOLE CANDIDATE FOR NOMINATION IN A PARTY'S

L3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
L4	SECTION 1. Section 23-15-295, Mississippi Code of 1972, is
L5	amended as follows:
L6	23-15-295. $\underline{(1)}$ When any person has qualified in the manner
L7	provided by law as a candidate for party nomination in any primary
L8	election, that person shall have the right to withdraw his name as
L9	a candidate by giving notice of his withdrawal in writing to the
20	secretary of the proper executive committee at any time before the
21	printing of the official ballots, and in the event of \underline{a} withdrawal
22	the name of $\underline{\text{the}}$ candidate shall not be printed on the ballot.
23	When a candidate for party nomination for a state or district
24	office who has qualified with the state executive committee
25	withdraws as a candidate as provided in this section after the
26	sample of the official ballot has been approved and certified by
27	the State Executive Committee $\underline{\prime}$ the Secretary or Chairman of the
28	State Executive Committee shall forthwith notify the county
29	executive committee of each county affected or involved of the
30	fact of $\underline{\text{the}}$ withdrawal and $\underline{\text{the}}$ notification shall authorize $\underline{\text{the}}$
31	county executive committees to omit the name of the withdrawn

- 32 candidate from the ballot if the notification is received before
- 33 the printing of the ballot. In the case of the withdrawal of any
- 34 candidate, the fee paid by the candidate shall be retained by the
- 35 state or county executive committee, as the case may be.
- 36 (2) (a) If after the qualifying deadline, but before the
- 37 primary election, there is only one candidate for nomination in a
- 38 party's primary election and that candidate dies, is removed,
- 39 withdraws or resigns from his candidacy for a legitimate
- 40 nonpolitical reason as defined in this section, and the death,
- 41 removal, withdrawal or resignation causes a complete vacancy on

- office wherein the vacancy occurred of the name of the nominee.

- 53 shall have the same force and effect and shall entitle the nominee
- 54 to all rights and privileges that would accrue to him as if he had
- 55 been nominated in the regular primary election. The nominee shall
- 56 have his name submitted as his party's nominee in the general

- (b) Any candidate who withdraws based upon a
- 59 "legitimate nonpolitical reason" which is not covered by the
- 60 definition in this section, shall have the strict burden of proof
- 61 for his reason.
- 62 (c) "Legitimate nonpolitical reason" as used in this
- 63 section shall be limited to the following:

64	(i) Reasons of health, which shall include any
65	health condition which, in the written opinion of a medical
66	doctor, would be harmful to the health of the candidate if he
67	continued.
68	(ii) Family crises, which shall include
69	circumstances which would substantially alter the duties and
70	responsibilities of the candidate to the family or to a family
71	business.
72	(iii) Substantial business conflict, which shall
73	include the policy of an employer prohibiting employees being
74	candidates for public offices, and an employment change which
75	would result in the ineligibility of the candidate or which would
76	impair his capability to properly carry out the functions of the
77	office being sought.
78	(d) A candidate who wishes to withdraw or resign for a
79	legitimate nonpolitical reason shall submit his reason by sworn
80	affidavit. The affidavit shall be filed with the state party
81	chairman of the candidate's party and the State Board of Election
82	Commissioners. No substitution of candidates shall be authorized,
83	except for death or disqualification, unless the State Board of
84	Election Commissioners approves the affidavit as constituting a
85	"legitimate nonpolitical reason" for the candidate's withdrawal or
86	resignation within five (5) days of the date the affidavit is
87	submitted to the board.
88	(e) Immediately upon approval or disapproval of the
89	affidavit, the State Board of Election Commissioners shall notify
90	the respective executive committee of same.
91	SECTION 2. The Attorney General of the State of Mississippi
92	shall submit this act, immediately upon approval by the Governor,
93	or upon approval by the Legislature subsequent to a veto, to the
94	Attorney General of the United States or to the United States
95	District Court for the District of Columbia in accordance with the

- 96 provisions of the Voting Rights Act of 1965, as amended and
- 97 extended.
- 98 SECTION 3. This act shall take effect and be in force from
- 99 and after the date it is effectuated under Section 5 of the Voting
- 100 Rights Act of 1965, as amended and extended, or from and after
- 101 July 1, 2001, whichever date is later.
