31 Any transfers or escalations shall be made in accordance with 32 the terms, conditions, and procedures established by law.

33 No general funds authorized to be expended herein shall be 34 used to replace federal funds and/or other special funds which are 35 being used for salaries authorized under the provisions of this 36 act and which are withdrawn and no longer available.

SECTION 3. The money herein appropriated shall be paid by 37 38 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 39 warrants issued by the State Fiscal Officer; and the State Fiscal 40 Officer shall issue his warrants upon requisitions signed by the 41 proper person, officer or officers, in the manner provided by law. 42 SECTION 4. This act shall take effect and be in force from 43 and after July 1, 2001. 44
