61 reduce the projected annual cost and/or the appropriation62 requirement will be processed by the State Personnel Board until

64 Any transfers or escalations shall be made in accordance with 65 the terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

SECTION 4. It shall be unlawful for any officer, employee or other person whatsoever to use or permit or authorize the use of any automobile or any other motor vehicle owned by the State of Mississippi or any department, agency or institution thereof for any purpose other than upon the official business of the State of Mississippi or any agency, department or institution thereof.

76 It is the intent of the Legislature that motor vehicles 77 authorized to be owned and operated by this agency shall comply 78 with Sections 25-1-77 through 25-1-93, Mississippi Code of 1972. 79 SECTION 5. The money herein appropriated shall be paid by 80 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 81 82 warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the 83 proper person, officer or officers, in the manner provided by law. 84 85 SECTION 6. This act shall take effect and be in force from and after July 1, 2001. 86
