SENATE BILL NO. 2238

1 AN ACT TO CREATE AND EMPOWER THE MISSISSIPPI COMMISSION ON
2 THE STATUS OF WOMEN; AND FOR RELATED PURPOSES.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

4 SECTION 1. (1) (a) There is hereby created the Mississippi
5 Commission on the Status of Women. The commission shall be
6 composed of thirteen (13) members to be appointed as follows:

7 (i) Five (5) members shall be appointed by the
8 Governor.

9 (ii) Five (5) members shall be appointed by the
10 Lieutenant Governor.

11 (iii) Three (3) members shall be appointed by the
12 Attorney General.

13 (b) The members of the commission shall be women and
14 men of recognized ability and achievement who are representative
15 of the ethnic and cultural diversity of the population of this
16 state. Members shall serve for terms of four (4) years each, and
17 no member may serve for more than two (2) consecutive terms. All
18 vacancies shall be filled by the appointing authority for the
19 unexpired term.

20 (c) The commission shall elect a chairman, vice
21 chairman and secretary from among its members for terms of two (2)
22 years each, and any member is eligible for successive elections to
23 office.

24 (d) A quorum for transacting business shall be a
25 majority of the members of the commission.

26 (e) Members of the commission shall be reimbursed for
27 expenses as provided in Section 25-3-41, Mississippi Code of 1972,



28 and shall receive per diem as provided in Section 25-3-69,
29 Mississippi Code of 1972.

30 (f) The Lieutenant Governor and the Attorney General
31 shall notify the Governor after they have made their appointments,
32 and the Governor shall then designate a place and time for the
33 initial organizational meeting of the commission.

34 (2) The commission shall have the powers and authority
35 necessary to carry out the duties imposed upon it by this act,
36 including, but not limited to, the following:

37 (a) To employ such administrative, technical and other
38 personnel as may be necessary for the performance of its powers
39 and duties;

40 (b) To hold hearings, make and sign any agreements and
41 do or perform any acts which may be necessary, desirable or proper
42 to carry out the purposes of this act;

43 (c) To cooperate with any state agency, authority,
44 board, commission, department or institution to facilitate its
45 implementation of the powers and duties granted to the commission
46 in this act; and each such state agency, authority, board,
47 commission, department or institution shall cooperate with the
48 commission in the performance of its duties;

49 (d) To appoint advisers or advisory committees, from
50 time to time, when the commission determines that the experience
51 or expertise of such advisers or advisory committees is needed for
52 projects of the commission; and

53 (e) To apply for and accept funds, grants, gifts and
54 services from the state, the government of the United States or
55 any of its agencies, or any other public or private source, for
56 the purpose of defraying clerical and administrative costs as may
57 be necessary in carrying out its duties under this act.

58 (3) (a) The commission shall study the following:

59 (i) Women's educational and employment problems,
60 needs and opportunities;



61 (ii) State laws in regard to the civil and
62 political rights of women, including pensions, tax requirements,
63 property rights, marriage and dissolution of marriage provisions,
64 and similar matters;

65 (iii) The effect of social attitudes and pressures
66 and economic considerations in shaping the roles to be assumed by
67 women in the society; and

68 (iv) Any laws, practices or conditions concerning
69 or affecting women which impose special limitations or burdens
70 upon them or upon society, or which limit or tend to limit
71 opportunities available to women.

72 (b) The commission shall act as an information center
73 on the status of women and women's educational, employment and
74 other related needs.

75 (c) The commission shall recommend, develop, prepare or
76 coordinate materials, projects or other activities and shall give
77 technical and consultative advice to public or private groups or
78 persons concerned with any of the following:

79 (i) Preventing or minimizing problems brought
80 about by the changing roles and responsibilities of women; and

81 (ii) Developing programs to encourage and enable
82 women to be fully contributing members of society.

83 (d) The commission may encourage women's organizations
84 and other groups to institute local self-help activities designed
85 to meet women's educational, employment and related needs.

86 (4) The commission shall make a report to the Legislature at
87 the close of each fiscal year on its activities, findings and
88 recommendations.

89 SECTION 2. This act shall take effect and be in force from
90 and after July 1, 2001.
