COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 2406

AN ACT TO AMEND SECTION 25-55-25, MISSISSIPPI CODE OF 1972, 1 TO REVISE THE PROVISION FOR ISSUANCE OF DUPLICATES OF LOST OR 2 DESTROYED WARRANTS; TO AMEND SECTION 25-55-27, MISSISSIPPI CODE OF 1972, IN CONFORMITY THERETO; AND FOR RELATED PURPOSES. 3 4 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. Section 25-55-25, Mississippi Code of 1972, is 6 amended as follows: 7 25-55-25. (1) A duplicate for a lost or destroyed 8 bond * * * shall not issue until there shall have been filed with 9 the officer an affidavit and a bond. The affidavit must be that 10 of some credible person knowing the facts, and it must set forth 11 the ownership of such bond * * *, the number of unpaid coupons, if 12 any, thereto attached, and the description thereof, embracing, if 13 can be, its number, to whom and for what issued, its date and when 14 mature. The bond must be that of a person to whom the duplicate 15 is to be issued, with at least two (2) sufficient sureties, in a 16 17 sum equal to double the amount of the lost, destroyed or stolen bond * * *, payable to the state, conditioned to pay all damages 18 which the state, county, city, town, or levee board, as the case 19 may be, may sustain if compelled to pay such bond or 20 coupons * * *, together with all costs and expenses and lawyers' 21 fees, if any, incurred in enforcing the bond. 22 23 (2) A duplicate for a lost or destroyed warrant shall not issue until there shall have been filed with the officer an 24 affidavit. The affidavit must be that of some credible person 25 knowing the facts, and it must set forth the ownership of such 26 warrant and the description thereof, embracing, if can be, its 27 number, to whom and for what issued, and its date. 28

Section 25-55-27, Mississippi Code of 1972, is 29 SECTION 2. amended as follows: 30 25-55-27. Any officer issuing duplicates of bonds * * * 31 32 shall keep a record showing: 33 (a) The numbers, dates and amounts of such mutilated, lost or destroyed bonds * * * and of the coupons thereto attached; 34 (b) * * * The date of the issuance of the 35 duplicate; * * * 36 (c) The name of the person to whom the duplicate was 37 issued; and 38 39 The name of the sureties and penalty of the (d) indemnity bond, if a bond is required. 40 The officer issuing duplicates of bonds shall preserve the 41 bond and affidavit taken in each case. 42 (2) Any officer issuing duplicates of warrants shall keep a 43 record showing: 44 The numbers, dates, and amounts of such mutilated, 45 (a) lost, or destroyed warrants; 46 The date of the issuance of the duplicate; and 47 (b) 48 (C) The name of the person to whom issued. The officer issuing duplicates of warrants shall preserve the 49 50 affidavit taken in each case. SECTION 3. This act shall take effect and be in force from 51 and after July 1, 2001. 52
