AN ACT TO CREATE A SPECIAL "CHOOSE LIFE" MOTOR VEHICLE 1 LICENSE TAG; TO PROVIDE THAT A PORTION OF THE FEE CHARGED FOR SUCH 2. TAG SHALL BE DISBURSED TO THE CHOOSE LIFE ADVISORY COMMITTEE; AND 3 4 FOR RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5 6 SECTION 1. (1) Any owner of a motor vehicle who is a 7 resident of this state, upon payment of the road and bridge 8 privilege taxes, ad valorem taxes and registration fees as prescribed by law for private carriers of passengers, pickup 9 10 trucks and other noncommercial motor vehicles, and upon payment of 11 an additional fee in the amount provided in subsection (4) of this section, shall be issued a distinctive license tag for each motor 12 13 vehicle registered in his name, which shall be produced in such color and design as the State Tax Commission, with the advice of 14 15 the Choose Life Advisory Committee, may prescribe. The words "Choose Life" shall be centered at the bottom of the license tag. 16 17 The State Tax Commission shall prescribe such letters or numbers, or both, as may be necessary to distinguish each license tag. 18 (2) Application for the distinctive license tags authorized 19 20 by this section shall be made to the county tax collector on forms 21 prescribed by the State Tax Commission. The application and the additional fee imposed under subsection (4) of this section, less 22 Two Dollars (\$2.00) to be retained by the tax collector, shall be 23 remitted to the State Tax Commission on a monthly basis as 24 25 prescribed by the commission. The portion of the additional fee 26 retained by the tax collector shall be deposited into the county 27 general fund.

- 28 Beginning with any registration year commencing on or 29 after July 1, 2001, any person applying for a distinctive license 30 tag under this section shall pay an additional fee in the amount 31 of Twenty-five Dollars (\$25.00) for each distinctive license tag 32 applied for under this section, which shall be in addition to all 33 other taxes and fees. The additional fee paid shall be for a period of time to run concurrent with the vehicle's established 34 license tag year. The additional fee is due and payable at the 35 time the original application is made for a distinctive license 36 37 tag under this section and thereafter annually at the time of 38 renewal registration as long as the owner retains the distinctive license tag.
