- 8 SECTION 1. All real and personal property, except motor
- 9 vehicles, owned by a not-for-profit foundation providing
- 10 charitable contributions and funding for legal services to the
- 11 poor, for projects to improve the administration of justice, for
- 12 assistance to the trial and appellate courts and similar
- 13 activities and purposes, shall be exempt from all ad valorem
- 14 taxation. Such property shall be exempt from ad valorem taxation
