SECTION 13. The money herein appropriated shall be paid by 146 147 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 148 warrants issued by the State Fiscal Officer; and the State Fiscal 149 150 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law. 151 152 SECTION 14. This act shall take effect and be in force from and after July 1, 2001. 153
