The following sum, or so much thereof as may be necessary, is hereby appropriated out of any money in the State 6 7 General Fund not otherwise appropriated, for the support and 8 maintenance of the Alcorn State University Agricultural Programs for the fiscal year beginning July 1, 2001, and ending June 30, 9 10 2002....\$ 4,739,758.00. 11 SECTION 2. The following sum, or so much thereof as may be 12 necessary, is hereby authorized for expenditure out of any special source funds which are collected by or otherwise become available, 13 for the support and maintenance of the Alcorn State University 14 Agricultural Programs for the fiscal year beginning July 1, 2001, 15 16 and ending June 30, 2002..... \$ 472,207.00. SECTION 3. Of the funds appropriated in Section 2, 17 Twenty-two Thousand Two Hundred Seven Dollars (\$22,207.00) shall 18 19 be derived from funds in the Education Enhancement Fund deposited 20 pursuant to Sections 27-65-75 and 27-67-31, Mississippi Code of 1972. 21 SECTION 4. No general funds authorized to be expended herein 22 23 shall be used to replace federal funds and/or other special funds which are being used for salaries which are withdrawn and no 24 25 longer available. 26 SECTION 5. 28 the Joint Legislative Budget Committee in a format and level of 29 detail comparable to the format and level of detail provided 30 during the Fiscal Year 2002 budget request process.

31 SECTION 6. The money herein appropriated shall be paid by 32 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 33 warrants issued by the State Fiscal Officer; and the State Fiscal 34 35 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law. 36 SECTION 7. This act shall take effect and be in force from 37 38 and after July 1, 2001.
