12	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
13	SECTION 1. (1) The Board of Supervisors of Monroe County,
14	Mississippi, the governing authorities of the City of Aberdeen,
15	Mississippi, and governing authorities of the City of Amory,
16	Mississippi, (hereinafter called governmental entities), are
17	hereby authorized and empowered, in their discretion, to jointly
18	or severally:
19	(a) Guarantee any loans made by financial institutions

- to the Monroe County Chamber of Commerce for the purchase of 20
- 21 property for, and construction of, speculative commercial
- 22 buildings;
- 23 (b) Pay the interest on any such loan during the term
- 24 of the loan; and
- 25 (c) Purchase any speculative commercial building
- constructed by the Monroe County Chamber of Commerce if the 26
- building has not been sold to a prospect by the end of the term of 27
- such a loan. 28
- 29 (2) The governmental entities are authorized and empowered,
- 30 in their discretion, to jointly or severally enter into agreements

- 31 with the Monroe County Chamber of Commerce and financial
- 32 institutions regarding the provisions of subsection (1) of this
- 33 section. The term of any such agreement shall not exceed five (5)
- 34 years and may extend beyond the term of office of the governing
- 35 body of the governmental entities.
