REPORT OF CONFERENCE COMMITTEE

MADAM PRESIDENT AND MR. SPEAKER:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

S. B. No. 2265: Dept. of Wildlife, Fisheries and Parks; authorize sale of property to V.F.W., Post 9122.

We, therefore, respectfully submit the following report and recommendation:

- 1. That the House recede from its Amendment No. 1.
- 2. That the Senate and House adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 7 SECTION 1. (1) The Mississippi Department of Wildlife, 8Fisheries and Parks, acting through the Department of Finance and 9Administration, upon meeting the requirements of Section 29-1-1, 10shall sell and convey to the Veterans of Foreign Wars, Post 9122, 11a parcel of state-owned property situated in Simpson County, 12Mississippi, and being more particularly described as follows:
- 13 Commence at the NE Corner of the SW/4 of the NE/4
- 14 Section 21, Township 1 North, Range 5 East, Simpson
- County, Mississippi, and run thence South 01° 39' W, 501
- 16 ft. to the Point of Beginning for the lands herein
- 17 conveyed. From said Point of Beginning continue and run
- 18 South 809 ft. to the SE Corner of said SW/4 of the NE/4,
- 19 Section 21; run thence North 89° 02' W, 751.27 ft. to a
- point on the R.O.W. of the Northbound Lane of U.S.
- 21 Highway 49; run thence North 47° 16' W, 110.75 ft. to a
- concrete marker; run North 55° 13' W, 186.82 ft. to a

concrete marker, continue North 34° 37' W, 156.08 ft. to
```

- 24 a concrete marker; thence continue to run along the
- 25 North R.O.W. line North 58° 00' W, 365 ft. to a point;
- from said point run thence North 76° 30' E, 1381 ft. to
- the Point of Beginning. All of said land lying and
- being situated in the SW/4 of the NE/4, Section 21,
- Township 1 North, Range 5 East, Simpson County,
- 30 Mississippi, containing in the aggregate 20 acres, more
- or less, and less and except that parcel heretofore
- 32 conveyed to the V.F.W. Post 9122 as same is recorded in
- 33 Deed Book 919 at Page 672 of the Land Records located in
- the Chancery Clerk's Office, Simpson County,
- 35 Mississippi.
- 36 (2) The real property described in subsection (1) of this 37 act shall be sold for not less than the current fair market value 38 as determined by the averaging of at least two (2) appraisals by 39 qualified appraisers who shall be selected by the Department of 40 Finance and Administration and shall be certified and licensed by 41 the Mississippi Real Estate Appraiser Licensing and Certification 42 Board.
- 43 (3) The proceeds from the sale and conveyance of the real
 44property described in subsection (1) of this section shall be used
 45first to reimburse the Department of Finance and Administration
 46for any costs incurred by the department regarding the sale and
 47conveyance, and the remaining proceeds from such sale and
 48conveyance shall be deposited into a special fund in the State
 49Treasury to be used by the Mississippi Department of Wildlife,
 50Fisheries and Parks for the general support of the department.
- 51 (4) When the Mississippi Department of Wildlife, Fisheries 52and Parks, acting through the Department of Finance and 53Administration, sells and conveys the real property described in

54subsection (1) of this section to the Veterans of Foreign Wars, 55Post 9122, then the Veterans of Foreign Wars, Post 9122, or any 56successor in interest, shall not establish, operate or maintain, 57within twenty-five (25) years after the effective date of this 58act, any weapons firing range or shooting range on the property or 59any courses or trails for the use of all-terrain vehicles on the 60property.

- 61 (5) The State of Mississippi shall retain all mineral rights 62to the real property sold pursuant to this section.
- 63 SECTION 2. This act shall take effect and be in force from 64 and after its passage.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT TO REQUIRE THE DEPARTMENT OF WILDLIFE, FISHERIES AND 2 PARKS, ACTING THROUGH THE DEPARTMENT OF FINANCE AND 3 ADMINISTRATION, TO SELL AND CONVEY TO THE VETERANS OF FOREIGN 4 WARS, POST 9122, CERTAIN STATE-OWNED LAND LOCATED IN SIMPSON 5 COUNTY, MISSISSIPPI; AND FOR RELATED PURPOSES.
