AMENDMENT No. 1 PROPOSED TO

House Bill NO. 385

By Representative(s) Chism, Frierson

1 **AMEND** by deleting SECTION 1 (lines 7 through 637) in its
2 entirety and by renumbering all succeeding sections accordingly.

3 **AMEND FURTHER** on lines 640 and 641 by deleting the following
4 language: ", in accordance with Section 31-7-13,".

5 **AMEND FURTHER** by inserting the following after the period on
6 line 644:

7 Before entering any contract for such insurance which has a value
8 of more than Ten Thousand Dollars (\$10,000.00), the school board
9 shall issue publicly a request for proposals. The request for
10 proposals must include a clear description of the minimum coverage
11 and services sought by the school district, the terms and
12 conditions relating to submission of proposals, the criteria upon
13 which an evaluation of the proposals will be based and any other
14 matters that the school board determines to be appropriate for
15 inclusion. Upon receiving responses to the request for proposals,
16 the school board shall select the lowest and best bid or bids on
17 the basis of price, coverage and any other relevant factors
18 determined to be appropriate by the school board. The school
19 board shall enter into its minutes the acceptance of a proposal
20 and the determining factors supporting its decision.

21 **AMEND FURTHER** on lines 675 and 676 by deleting the following
22 language: ", in accordance with Section 31-7-13,".

23 **AMEND FURTHER** by inserting the following after the period on
24 line 678:

25 Before entering any contract for such insurance which has a value
26 of more than Ten Thousand Dollars (\$10,000.00), the school board
27 shall issue publicly a request for proposals. The request for
28 proposals must include a clear description of the minimum coverage
29 and services sought by the school district, the terms and
30 conditions relating to submission of proposals, the criteria upon
31 which an evaluation of the proposals will be based and any other
32 matters that the school board determines to be appropriate for
33 inclusion. Upon receiving responses to the request for proposals,
34 the school board shall select the lowest and best bid or bids on
35 the basis of price, coverage and any other relevant factors
36 determined to be appropriate by the school board. The school
37 board shall enter into its minutes the acceptance of a proposal
38 and the determining factors supporting its decision.

39 **AMEND FURTHER** on line 679 by inserting after the word
40 "education" the language "or adequate education".

41 **AMEND FURTHER the TITLE** by deleting all after the word
42 "AMEND" on line 1 through the word "AMEND" on line 3, and by
43 striking the language "IN CONFORMITY THERETO" on line 4 and
44 inserting in lieu thereof the following: "TO REQUIRE SCHOOL
45 DISTRICTS TO ISSUE REQUESTS FOR PROPOSALS FOR INSURANCE CONTRACTS
46 OVER \$10,000.00".
