Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	General Fund not otherwise appropriated, for the purpose of
8	defraying the expenses of The University of Mississippi Medical
9	Center for the fiscal year beginning July 1, 2001, and ending
LO	June 30, 2002\$ 138,809,858.00.
L1	SECTION 2. The following sum of money, or so much thereof as
L2	may be necessary, is hereby authorized and approved for
L3	expenditure out of the proceeds derived from patient fees, student
L4	fees or any other special source funds which are collected by or
L5	otherwise become available, for the support and maintenance of The
L6	University of Mississippi Medical Center for the fiscal year
L7	beginning July 1, 2001, and ending June 30, 2002
L8	\$ 420,629,630.00.
L9	SECTION 3. Any escalations shall be made in accordance with
20	the terms, conditions, and procedures established by law.
21	No general funds authorized to be expended herein shall be

- 22 used to replace federal funds and/or other special funds which are
- 23 being used for salaries authorized under the provisions of this
- 24 act and which are withdrawn and no longer available.
- 25 SECTION 4. With the funds appropriated and authorized for
- 26 expenditure under the provisions of Section 1 and Section 2, the
- 27 University of Mississippi Medical Center shall maintain the School
- 28 of Medicine, the School of Dentistry, the School of Nursing, the
- 29 School of Health Related Professions, the Teaching Hospital and
- 30 the Medical Center Service Area. The University of Mississippi
- 31 Medical Center shall prepare and make available to the Legislature
- 32 an accounting of expenditures for each of the divisions listed in
- 33 this section at the beginning of the legislative session.
- 34 SECTION 5. Due to critical nurse shortages and staffing, it
- 35 is the intent of the Legislature to enhance recognition of
- 36 excellence and expand the experience factor in attracting
- 37 qualified registered nurses.
- 38 SECTION 6. Of the funds appropriated in Section 1, and the
- 39 funds authorized to be expended in Section 2, none may be used to
- 40 provide medical services on behalf of any state agency,
- 41 institution or political subdivision, except to the extent that
- 42 such agency, institution or political subdivision reimburses the
- 43 hospital for the cost of the services provided. Upon the
- 44 rendering of medical services to any such agency, institution or
- 45 political subdivision, the hospital shall issue an invoice for the
- 46 charges which shall be paid within ninety (90) days. In the event
- 47 that payment is not made within ninety (90) days, the hospital
- 48 shall discontinue providing services to that agency, institution,
- 49 or political subdivision until all outstanding charges have been
- 50 paid.
- 51 SECTION 7. Any funds appropriated pursuant to this act and

- 52 paid as a fee to or deposited in a financial institution shall be
- 53 in compliance with Section 109 of the Constitution of the State of
- 54 Mississippi and Section 25-4-103, Mississippi Code of 1972.
- SECTION 8. It is the intention of the Legislature that the
- 56 University of Mississippi Medical Center's budget request for
- 57 Fiscal Year 2003 shall be submitted to the Joint Legislative
- 58 Budget Committee in a format and level of detail comparable to the
- 59 format and level of detail provided during the Fiscal Year 2002
- 60 budget request process.
- 61 SECTION 9. Of the funds authorized for expenditure in
- 62 Section 2, Four Million Fifty-seven Thousand Seven Hundred Fifteen
- Ollars (\$4,057,715.00) shall be derived from the Education
- 64 Enhancement Fund from funds deposited pursuant to Sections
- 65 27-65-75 and 27-67-31, Mississippi Code of 1972.
- SECTION 10. The money herein appropriated shall be paid by
- 67 the State Treasurer out of any money in the State Treasury to the
- 68 credit of the proper fund or funds as set forth in this act, upon
- 69 warrants issued by the State Fiscal Officer; and the State Fiscal
- 70 Officer shall issue his warrants upon requisitions signed by the
- 71 proper person, officer or officers, in the manner provided by law.
- 72 SECTION 11. This act shall take effect and be in force from
- 73 and after July 1, 2001.
