23 With the funds herein appropriated, it is the intention of the Legislature that it shall be the agency's responsibility to 24 25 make certain that funds required to be appropriated for "Personal 26 Services" for Fiscal Year 2003 do not exceed Fiscal Year 2002 27 funds appropriated for that purpose, unless programs or positions are added to the agency's Fiscal Year 2003 budget by the 28 29 Mississippi Legislature. Based on data provided by the 30 Legislative Budget Office, the State Personnel Board shall 31 determine and publish the projected annual cost to fully fund all 32 appropriated positions in compliance with the provisions of this It shall be the responsibility of the agency head to insure 33 act. 34 that no single personnel action increases this projected annual 35 cost and/or the Fiscal Year 2002 appropriation for "Personal 36 Services" when annualized. If, at the end of any calendar month, 37 the State Personnel Board determines that the agency has taken action(s) which would cause the agency to exceed this projected 38 annual cost or the Fiscal Year 2002 "Personal Services" 39 appropriated level, when annualized, then only those actions which 40 reduce the projected annual cost and/or the appropriation 41 42 requirement will be processed by the State Personnel Board until 43 such time as the requirements of this provision are met. 44 Any transfers or escalations shall be made in accordance with

45 the terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.
