Amend by striking all after the enacting clause and inserting in lieu thereof the following:

12 SECTION 1. Section 27-19-56.15, Mississippi Code of 1972, is 13 amended as follows: 27-19-56.15. (1) (a) Any owner of a motor vehicle who is a 14 resident of this state, upon complying with the motor vehicle laws 15 relating to registration and licensing of motor vehicles, and upon 16 17 payment of the road and bridge privilege taxes, ad valorem taxes and registration fees as prescribed by law for private carriers of 18 19 passengers, pickup trucks and other noncommercial motor vehicles, and upon payment of an additional annual fee in the amount of 20 21 Fifty Dollars (\$50.00), shall be issued a distinctive license tag that displays the emblem of any public or private university of 22 23 his choice located in another state. 24 The design of the emblems for the distinctive license tags authorized under this subsection shall be determined 25 26 by agreement between the State Tax Commission and the governing authorities of public or private universities in the states where 27 28 the universities are located. Such other design characteristics

- 29 and information to be contained on such distinctive license tags
- 30 shall be determined by the State Tax Commission.
- 31 (c) Application for the distinctive license tag
- 32 authorized under this subsection shall be made to the county tax
- 33 collector on forms prescribed by the State Tax Commission. The
- 34 application and the additional fee, less Two Dollars (\$2.00) to be
- 35 retained by the tax collector, shall be remitted to the State Tax
- 36 Commission within seven (7) days of the date that the application
- 37 is made. The portion of the additional fee retained by the tax
- 38 collector shall be deposited into the county general fund.
- 39 (d) The State Tax Commission shall deposit all fees
- 40 that it receives under this subsection into the State Treasury on
- 41 the day received. At the end of each month, the State Tax
- 42 Commission shall certify the total fees collected under this
- 43 section to the State Treasurer who shall distribute such
- 44 collections as follows:
- 45 (i) Twenty-five Dollars (\$25.00) of the additional
- 46 fees collected from each distinctive license tag issued under this
- 47 subsection shall be distributed to the World War II Veterans
- 48 Memorial in Washington, D.C. However, when the amounts
- 49 distributed to the World War II Veterans Memorial reaches an
- 50 aggregate amount of One Hundred Thousand Dollars (\$100,000.00),
- 51 then Twenty-five Dollars (\$25.00) of such additional fees shall be
- 52 deposited into the State General Fund.
- (ii) One Dollar (\$1.00) of each additional fee
- 54 collected on distinctive license tags issued pursuant to this
- 55 section shall be deposited into the Mississippi Fire Fighter's
- 56 Memorial Burn Center Fund created pursuant to Section 7-9-70.
- 57 (iii) <u>Twenty-two Dollars (\$22.00)</u> of each
- 58 additional fee collected on distinctive license tags issued

- 59 pursuant to this section shall be deposited to the credit of the
- 60 State Highway Fund to be expended solely for the repair,
- 61 maintenance, construction or reconstruction of highways.
- 62 (2) A regular license tag must be properly displayed as
- 63 required by law until replaced by a distinctive license tag under
- 64 this section. The regular license tag must be surrendered to the
- 65 tax collector upon issuance of the distinctive license tag under
- 66 this section. The tax collector shall issue up to two (2) license
- 67 decals for each distinctive license tag issued under this section,
- 68 which will expire the same month and year as the regular license
- 69 tag.
- 70 (3) In the case of loss or theft of a distinctive license
- 71 tag issued under this section, the owner may make application and
- 72 affidavit for a replacement distinctive license tag as provided by
- 73 Section 27-19-37. The fee for a replacement distinctive license
- 74 tag shall be Ten Dollars (\$10.00). The tax collector receiving
- 75 such application and affidavit shall be entitled to retain and
- 76 deposit into the county general fund five percent (5%) of the fee
- 77 for such replacement license tag and the remainder shall be
- 78 distributed in the same manner as funds from the sale of regular
- 79 distinctive license tags issued under this section.
- 80 SECTION 2. This act shall take effect and be in force from
- 81 and after July 1, 2001.
