1 2 3 4	AN ACT MAKING AN APPROPRIATION FROM THE LEGISLATIVE EXTRAORDINARY SESSION EXPENSE REVOLVING FUND TO PAY FOR THE EXPENSES OF THE MISSISSIPPI LEGISLATURE FOR THE SECOND EXTRAORDINARY SESSION OF 2001.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
6	SECTION 1. That the following sums, or so much thereof as
7	may be necessary, are hereby appropriated out of any money in the
8	State Treasury to the credit of the Legislative Extraordinary
9	Session Expense Revolving Fund not otherwise appropriated, for the
10	purpose of paying salaries, mileage, insurance, matching funds and
11	the daily expense allowance of the members of the Legislature for
12	the Second Extraordinary Session of 2001, as follows:
13	For salaries, mileage, insurance,
14	matching funds and daily
15	expense allowance of members
16	of the House of Representatives\$ 33,446.00.
17	For salaries, mileage, insurance,
18	matching funds and daily
19	expense allowance of members
20	of the Senate\$ 14,621.00.
21	SECTION 2. In accordance with Section 5-1-57, Mississippi
22	Code of 1972, the Legislature shall have the authority to escalate
23	its budget and expend funds from the Legislative Extraordinary
24	Session Expense Revolving Fund not to exceed the amount stated in
25	Section 5-1-57, Mississippi Code of 1972, to pay the expenses
26	incurred by the members of the legislature and other expenses of
27	the Second Extraordinary Session of 2001, in accordance with rules
28	and regulations of the Department of Finance and Administration in

- 29 a manner consistent with the escalation of federal funds. Such
- 30 funds shall be used only when the Legislature is required by the
- 31 Governor to meet in extraordinary session for the consideration of
- 32 matters of public interest and can only be used to pay the
- 33 expenses incurred by the members of the Legislature and other
- 34 expenses of the Second Extraordinary Session of 2001.
- 35 SECTION 3. The money herein appropriated shall be paid by
- 36 the State Treasurer out of any money in the proper fund or funds
- 37 as set forth in this act, upon warrants issued by the State Fiscal
- 38 Officer; and the State Fiscal Officer shall issue his warrants
- 39 upon requisitions signed by the proper person, officer or
- 40 officers, in the manner provided by law.
- 41 SECTION 4. This act shall take effect and be in force from
- 42 and after its passage and through June 30, 2002.
