HOUSE BILL NO.

- AN ACT TO AMEND SECTION 63-1-47, MISSISSIPPI CODE OF 1972, TO 1 REQUIRE EVERY PERSON, UPON EACH RENEWAL OF A DRIVER'S LICENSE, 2 EXCEPT UPON RENEWAL OF A DRIVER'S LICENSE BY ELECTRONIC MEANS, TO TAKE AND PASS A VISION SCREENING EXAMINATION TO BE ADMINISTERED BY 3 4
- THE DEPARTMENT OF PUBLIC SAFETY; AND FOR RELATED PURPOSES. 5
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 SECTION 1. Section 63-1-47, Mississippi Code of 1972, is
- amended as follows: 8
- 9 63-1-47. (1) Each applicant for an original license issued
- pursuant to this article, who is entitled to issuance of same, and 10
- who is eighteen (18) years of age or older, shall be issued a 11
- four-year license. Each license will expire at midnight on the 12
- 13 licensee's birthday.
- 14 All renewal licenses of operators eighteen (18)
- years of age or older shall be for four-year periods and may be 15
- renewed any time within six (6) months before the expiration of 16
- the license upon application and payment of the required fee, 17
- unless required to be reexamined. 18
- 19 (b) Every person, upon each renewal of a driver's
- license, except upon renewal of a driver's license by electronic 20
- means as authorized under Section 63-1-35, in addition to 21
- 22 complying with all other requirements for the renewal of a
- 23 driver's license, must take and pass a vision screening
- examination to be administered by the Department of Public Safety. 24
- No additional fee shall be charged by the department for 25
- administering such examination. 26
- (c) From and after January 1, 1990, no commercial 27
- 28 driver's license shall be issued under the provisions of this

article for any commercial motor vehicle, the lawful operation of 29 30 which requires the driver to obtain a Class A, B or C commercial driver's license under Article 2 of this chapter; however, from 31 time to time, the holder of a commercial license may apply for a 32 33 commercial driver's license under Article 2 of this chapter; and, 34 if he fails to pass the required test for such license, he shall be entitled to an extension of his license that shall be valid for 35 one hundred twenty (120) days or until he again is tested under 36 Article 2 of this chapter, whichever occurs first. The extension 37 shall entitle the license holder to operate all vehicles which 38 such license authorized him to operate prior to taking the 39 required test. The first extension shall be without charge; 40 however, a fee of Fifteen Dollars (\$15.00) shall be imposed for 41 any subsequent extension. No extension shall be valid past March 42

Any commercial driver's license issued under this 45 article before January 1, 1990, which expires after March 31, 46 1992, shall be void on April 1, 1992, for the operation of any 47 48 commercial vehicle requiring a commercial license to be issued under Article 2 of this chapter; however, if the holder of any 49 50 such license applies for a commercial driver's license under Article 2 of this chapter, passes the required tests for such 51 license, pays all applicable fees under Article 2 of this chapter 52 53 except the Forty Dollars (\$40.00) license fee and otherwise meets all requirements for the issuance of such license, then such 54 55 person shall be issued a license under Article 2 of this chapter which shall expire on the expiration date of the commercial 56 driver's license being replaced. 57

- 79 (18) years of age, shall be issued a one-year license which will
- 80 expire at midnight on the licensee's birthday. Renewal driver's
- 81 licenses of operators under the age of eighteen (18) shall be for
- 82 one-year periods and may be renewed any time within two (2) months
- 83 before the expiration of the license upon application and payment
- 84 of the required fee, unless required to be reexamined. An
- 85 intermediate license shall be valid for one (1) year from its date
- 86 of issue and may be renewed any time within fourteen (14) days
- 87 before expiration of the license. All applications by an operator
- 88 under the age of eighteen (18) must be accompanied by

- 89 documentation that the applicant is in compliance with the
- 90 education requirements of Section 63-1-9(1)(g); the documentation
- 91 must be dated no more than thirty (30) days prior to the date of
- 92 application.
- 93 **SECTION 2.** This act shall take effect and be in force from
- 94 and after July 1, 2002.
