HOUSE BILL NO. 205

- AN ACT TO CODIFY NEW CODE SECTION 73-39-43, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE MISSISSIPPI BOARD OF VETERINARY MEDICINE
- TO CERTIFY ANIMAL CONTROL AGENCIES TO UTILIZE CERTAIN CONTROLLED SUBSTANCES FOR THE HUMANE DESTRUCTION OF ANIMALS AND TO CERTIFY 3
- AND PRESCRIBE QUALIFICATIONS FOR CERTIFIED ANIMAL EUTHANASIA
- TECHNICIANS (CAET) TO PERFORM EUTHANASIA OF ANIMALS; TO AMEND 6
- SECTION 73-39-9, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE 7
- MISSISSIPPI BOARD OF VETERINARY MEDICINE TO ADOPT RULES IN 8
- CONFORMITY THERETO; AND FOR RELATED PURPOSES. 9
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 10
- 11 SECTION 1. The following section shall be codified as
- Section 73-39-43, Mississippi Code of 1972: 12
- 73-39-43. (1) For purposes of this section, the following 13
- terms shall have the meanings ascribed herein, unless the context 14
- 15 clearly indicates otherwise:
- 16 "Certified animal control agency" means a federal,
- county or municipal animal shelter, dog pound or animal control 17
- agency, private humane society, state, county or municipal law 18
- enforcement agency, or any combination thereof, which temporarily 19
- houses stray, unwanted or injured animals and which is certified 20
- 21 pursuant to the provisions of this section.
- (b) "Certified animal euthanasia technical (CAET)" 22
- means a person employed by a certified animal control agency who 23
- 24 is authorized by the Mississippi Board of Veterinary Medicine to
- perform euthanasia on animals with approved scheduled substances. 25
- "Board" means the Mississippi Board of Veterinary 26 (C)
- Medicine. 27
- The Mississippi Board of Veterinary Medicine shall (2) 28 (a)
- 29 adopt rules providing for the issuance of permits for the
- purchase, possession and use of sodium pentobarbital or other 30

- 31 board approved drugs for euthanasia by certified animal control
- 32 agencies. The rules shall set forth guidelines for the proper
- 33 storage and handling of the substances and other provisions as may
- 34 be necessary to ensure that these drugs are used solely for the
- 35 purpose set forth in this section. The rules shall also provide
- 36 for an application or inspection fee and a renewal fee at set
- 37 intervals.
- 38 (b) Upon certification by the board that the applying
- 39 agency meets the qualifications set forth in the rules, a permit
- 40 shall be issued.
- 41 (c) The board may revoke or suspend the permit upon the
- 42 determination that the permittee fails to follow the rules of the
- 43 board regarding proper storage and handling or use of approved
- 44 euthanasia substances.
- 45 (3) (a) Euthanasia of animals in a certified animal control
- 46 agency may only be performed by a licensed veterinarian, including
- 47 a licensed veterinary technician employed by and functioning under
- 48 the direct supervision of a licensed veterinarian, or a certified
- 49 animal euthanasia technician as provided by law. A certified
- 50 animal control agency which employs a certified animal euthanasia
- 51 technician may purchase, possess and administer sodium
- 52 pentobarbital or such other drug which the board may approve for
- 53 the euthanasia of animals. Sodium pentobarbital and such other
- 54 drugs approved by the board shall be the only drugs used for the
- 55 euthanasia of animals in a certified animal control agency. Upon
- 56 submission of a complete application, payment of a fee established
- 57 by the board and successful completion of a board-approved animal
- 58 euthanasia specialist training course by the applicant, the Board
- 59 of Veterinary Examiners shall issue to any person whom it
- 60 determines to be qualified a certificate for the person to
- 61 function as a certified animal euthanasia specialist.
- (b) No officer or agent of a certified animal control
- 63 agency or veterinarian acting in good faith and with due care

- 64 pursuant to this act may be held liable either criminally or
- 65 civilly for that act, nor shall any civil or criminal liability
- 66 attach to the employer of the officer, agent or veterinarian.
- 67 (c) A court order shall not be necessary to carry out
- 68 this section.
- 69 (4) Any person who violates this act shall be guilty of a
- 70 misdemeanor and upon conviction shall be punished by a fine not
- 71 exceeding Five Hundred Dollars (\$500.00) or imprisonment in the
- 72 county jail for a term not exceeding six (6) months or both.
- 73 SECTION 2. Section 73-39-9, Mississippi Code of 1972, is
- 74 amended as follows:
- 75 73-39-9. The board shall elect from their members a
- 76 president, vice president and secretary-treasurer. The board is
- 77 authorized:
- 78 (a) To adopt reasonable rules governing the practice of
- 79 veterinary medicine as are necessary to enable it to carry out and
- 80 make effective the purpose and intent of this chapter. Such rules
- 81 shall be adopted and promulgated in accordance with the provisions
- 82 of this chapter.
- 83 (b) To adopt rules of professional conduct appropriate
- 84 to establish and maintain a high standard of integrity, skills and
- 85 practice in the profession of veterinary medicine. In prescribing
- 86 such rules of professional conduct, the board may be guided by the
- 87 principles of veterinary medical ethics adopted by the American
- 88 Veterinary Medical Association and the Mississippi Veterinary
- 89 Medical Association.
- 90 (c) To have its rules printed which shall be
- 91 distributed to all licensed veterinarians.
- 92 (d) To bring proceedings in courts for the enforcement
- 93 of this chapter or any rules made pursuant thereto.
- 94 (e) To hold at least one (1) regular meeting on the
- 95 third Tuesday in June each year in the City of Jackson at such
- 96 time and location as fixed by the board, for the purpose of

- 97 conducting examinations of applicants for license to practice
- 98 veterinary medicine, the election of officers and to consider any
- 99 other business that may properly come before the board. Other
- 100 meetings may be held upon the call of the president and secretary
- 101 of the board.
- 102 (f) To pass upon the qualifications of applicants for a
- 103 license to practice veterinary medicine in this state, or for a
- 104 certificate as an animal technician.
- 105 (g) To prescribe the subjects, character, manner, time
- 106 and place of holding examinations and the filing of applications
- 107 for examinations and to conduct the examinations.
- 108 (h) To issue temporary permits to practice to duly
- 109 qualified applicants which shall be signed by the secretary.
- 110 (i) To provide for, regulate and require all persons
- 111 licensed in accordance with the provisions of this chapter to
- 112 renew their license annually; to require as a condition precedent
- 113 to such annual renewal the payment of the annual renewal fee as
- 114 provided herein; to issue annual renewal licenses to such persons
- 115 and to suspend or revoke the license of such persons who fail,
- 116 refuse or neglect to renew same or pay such fees.
- 117 (j) To conduct investigations and hearings upon
- 118 complaints calling for discipline of a licensee or applicant for
- 119 license.
- 120 (k) To take testimony on any matter under its
- 121 jurisdiction and any member thereof may administer oaths.
- 122 (1) To issue summons and subpoenas, including subpoenas
- 123 duces tecum, for any witness in connection with any matter within
- 124 the jurisdiction of the board, which shall be signed by either the
- 125 president or the secretary-treasurer of the board.
- 126 (m) To adopt such forms as it may deem necessary.
- 127 (n) To adopt rules and regulate the certification of
- 128 <u>animal control agencies and animal euthanasia technicians pursuant</u>
- 129 <u>to Section 73-39-43.</u>
