## HOUSE BILL NO. 402

- AN ACT TO AMEND SECTION 37-103-25, MISSISSIPPI CODE OF 1972,
  TO REQUIRE STATE INSTITUTIONS OF HIGHER LEARNING AND COMMUNITY AND
  JUNIOR COLLEGES TO WAIVE OUT-OF-STATE TUITION FOR NONRESIDENTS
  WHOSE PARENTS ARE ALUMNI OF A STATE INSTITUTION OF HIGHER LEARNING
  WHO ALSO OWN REAL PROPERTY IN MISSISSIPPI; TO AMEND SECTIONS
  37-29-81 AND 37-29-423, MISSISSIPPI CODE OF 1972, IN CONFORMITY TO
- 6 37-29-81 AND 37-29-423, MISSISSIPPI CODE OF 1972, IN CONFORMITY TO THE PROVISIONS OF THIS ACT; AND FOR RELATED PURPOSES.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 37-103-25, Mississippi Code of 1972, is 10 amended as follows:
- 11 37-103-25. (1) The Board of Trustees of State Institutions
- 12 of Higher Learning and the boards of trustees of the community
- 13 colleges and junior colleges are \* \* \* authorized to prescribe the
- 14 amount of tuition and fees to be paid by students attending the
- 15 several state-supported institutions of higher learning and
- 16 <u>community colleges and</u> junior colleges of the State of
- 17 Mississippi. \* \* \*
- 18 (2) Except as otherwise provided in this subsection, the
- 19 total tuition to be paid by residents of other states shall not be
- 20 less than the average cost per student from appropriated funds.
- 21 However, the tuition to be paid by a resident of another state
- 22 must be equal to the tuition amount established under subsection
- (1) of this section if:
- 24 (a) Both the mother and father of the nonresident
- 25 student are graduates of a state institution of higher learning in
- 26 Mississippi; and
- 27 (b) Both the mother and father of the nonresident
- 28 student own real property within the State of Mississippi.

- SECTION 2. Section 37-29-81, Mississippi Code of 1972, is
- 30 amended as follows:
- 31 37-29-81. The district, in the discretion of the board of
- 32 trustees, may charge fees and tuitions in accordance with Section
- 33 37-103-25.
- 34 SECTION 3. Section 37-29-423, Mississippi Code of 1972, is
- 35 amended as follows:
- 36 37-29-423. The Mississippi Gulf Coast Junior College
- 37 District, in the discretion of the board of trustees, may charge
- 38 fees and tuitions in accordance with Section 37-103-25.
- 39 **SECTION 4.** This act shall take effect and be in force from
- 40 and after July 1, 2002.
