- 22 privilege license for the purpose of authorizing such person to

- 24 at retail shall present to the tax collector at the time of
- 25 application for a privilege license a valid certificate issued by
- 26 the Mississippi Motor Vehicle Commission evidencing that such
- 27 person has met the annual continuing education requirements
- 28 prescribed by Section 63-17-82 for used car dealers and salesmen.
- 29 The tax collector shall not issue a privilege license to such
- 30 person unless the certificate accompanies the application.
