- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- **SECTION 1.** (1) In addition to any other fines, penalties or 9
- 10 offenses provided by law, it shall be unlawful to:
- Sell any alcoholic beverage from any building or 11
- structure designed to allow a motor vehicle to drive by, in or 12
- through a portion of the building; or 13
- (b) Sell any light wine or beer, or both, from any 14
- 15 building or structure designed to allow a motor vehicle to drive
- by, in or through a portion of the building, unless (i) the 16
- building is designed solely for sales of light wine or beer, or 17
- both, (ii) the building is designed to require a motor vehicle to 18
- pass completely through the building, and (iii) sales of light 19
- wine or beer, or both, are permitted within the building by virtue 20
- of a valid privilege license issued under Chapter 3, Title 67, 21
- Mississippi Code of 1972. 22
- 23 (2) (a) Any person who violates this section shall be
- fined, upon conviction thereof, not less than Five Hundred Dollars 24
- (\$500.00) and not more than One Thousand Dollars (\$1,000.00) for 25
- each offense. 26
- Any permittee licensed to sell alcoholic beverages (b) 27
- 28 or licensed to sell light wine or beer, or both, who violates the
- provisions of this section shall be punished, upon conviction 29

- 30 thereof, by suspension of his permit or license for one (1) year.
- 31 Upon conviction of a second offense under the provisions of this
- 32 section, the permit or license shall be revoked automatically and
- 33 permanently.
- 34 SECTION 2. Section 1 of this act shall be codified as a
- 35 separate code section in Title 67, Mississippi Code of 1972.
- 36 **SECTION 3.** This act shall take effect and be in force from
- 37 and after July 1, 2002.
