- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 97-9-73, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 97-9-73. (1) It shall be unlawful for any person to
- 8 obstruct or resist by force, or violence, or threats, or in any
- 9 other manner, his lawful arrest or the lawful arrest of another
- 10 person by any state, local or federal law enforcement officer, and
- 11 any person or persons so doing shall be quilty of a misdemeanor,
- 12 and upon conviction thereof, shall be punished by a fine of not
- 13 more than Five Hundred Dollars (\$500.00), or by imprisonment in
- 14 the county jail not more than six (6) months, or both.
- 15 (2) It is unlawful for the operator of a motor vehicle,
- 16 having knowledge that he or she has been ordered to stop such
- 17 vehicle by a duly authorized law enforcement officer, willfully to
- 18 refuse or fail to stop the vehicle in compliance with such order
- 19 or, having stopped in knowing compliance with such order,
- 20 willfully to flee in an attempt to elude the officer, and a person
- 21 who violates this subsection shall be guilty of a misdemeanor and
- 22 upon conviction shall be punished by a fine not to exceed One
- 23 Thousand Dollars (\$1,000.00) or imprisoned in the county jail for
- 24 <u>a term not to exceed six (6) months, or both.</u>
