## HOUSE BILL NO. 805

AN ACT TO AMEND SECTION 57-1-301, MISSISSIPPI CODE OF 1972, 1 TO REVISE THE DEFINITION OF "CAPITAL IMPROVEMENTS" TO INCLUDE THE 2 3 CONSTRUCTION, REPAIR OR RENOVATION OF RECREATION AND ATHLETIC 4 FACILITIES WITHIN THOSE CAPITAL IMPROVEMENTS FOR WHICH ASSISTANCE IS AVAILABLE UNDER THE LOCAL GOVERNMENTS CAPITAL IMPROVEMENTS 5 REVOLVING LOAN PROGRAM; TO REFLECT THE CHANGE OF THE NAME OF THE 6 MISSISSIPPI DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT TO 7 THE MISSISSIPPI DEVELOPMENT AUTHORITY; AND FOR RELATED PURPOSES. 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 9 SECTION 1. Section 57-1-301, Mississippi Code of 1972, is 10 11 amended as follows: (1) There is established a Local Governments 57-1-301. 12 Capital Improvements Revolving Loan Program to be administered by 13 the Mississippi Development Authority for the purpose of assisting 14 counties and municipalities in making capital improvements. 15 For purposes of Sections 57-1-301 and 57-1-335, "capital (2) 16 improvements" include any combination of the following: 17 Construction or repair of water and sewer 18 (a) 19 facilities; Construction or repair of drainage systems for 20 (b) 21 industrial development; Improvements in fire protection; 22 (C) 23 (d) Construction of new buildings for economic development purposes; 24 Renovation or repair of existing buildings for 25 (e) economic development purposes; 26 Construction or repair of access roads for 27 (f) 28 industrial development; Purchase of buildings for economic development 29 (g) 30 purposes; H. B. No. 805 G1/2 02/HR40/R1380

Construction or repair of railroad spurs for 31 (h) industrial development; 32 (i) Construction of any county or municipally owned 33 health care facilities, excluding any county health departments; 34 35 (j) Construction, purchase, renovation or repair of any building to be utilized as an auditorium or convention center; 36 37 (k) Construction of multipurpose facilities for tourism development; \* \* \* 38 Loans to a county to aid in retiring (1) 39 interest-bearing loans utilized for the purchase of a motion 40 41 picture sound stage; or (m) Construction, repair or renovation of recreation 42 43 and athletic facilities. SECTION 2. This act shall take effect and be in force from 44 and after July 1, 2002. 45
