HOUSE BILL NO. 1029

1 AN ACT TO AMEND SECTION 25-3-13, MISSISSIPPI CODE OF 1972, TO
2 REVISE THE SALARY SCALE FOR MEMBERS OF THE BOARDS OF SUPERVISORS
3 AND TO AUTHORIZE AN ANNUAL SALARY SUPPLEMENT FOR MEMBERS WHO
4 COMPLETE THE LEADERSHIP PROGRAM FOR COUNTY SUPERVISORS
5 ADMINISTERED BY THE CENTER FOR GOVERNMENTAL TECHNOLOGY,
6 MISSISSIPPI STATE UNIVERSITY EXTENSION SERVICE; AND FOR RELATED
7 PURPOSES.

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

9 **SECTION 1.** Section 25-3-13, Mississippi Code of 1972, is
10 amended as follows:

11 25-3-13. (1) The salaries of the members of the boards of
12 supervisors of the various counties are * * * fixed as full
13 compensation for their services.

14 The annual salary of each member of the board of supervisors
15 shall be based upon the total assessed valuation of his respective
16 county for the preceding taxable year in the following categories
17 and for the following amounts:

18 (a) For counties having a total assessed valuation of
19 One Billion Dollars (\$1,000,000,000.00) or more, a salary of
20 Thirty-nine Thousand Dollars (\$39,000.00);

21 (b) For counties having a total assessed valuation of
22 at least Five Hundred Million Dollars (\$500,000,000.00), but less
23 than One Billion Dollars (\$1,000,000,000.00), a salary of
24 Thirty-eight Thousand Seven Hundred Fifty Dollars (\$38,750.00);

25 (c) For counties having a total assessed valuation of
26 at least Two Hundred Million Dollars (\$200,000,000.00), but less
27 than Five Hundred Million Dollars (\$500,000,000.00), a salary of
28 Thirty-eight Thousand Five Hundred Dollars (\$38,500.00);



29 (d) For counties having a total assessed valuation of
30 at least One Hundred Million Dollars (\$100,000,000.00), but less
31 than Two Hundred Million Dollars (\$200,000,000.00), a salary of
32 Thirty-seven Thousand Dollars (\$37,000.00);

33 (e) For counties having a total assessed valuation of
34 less than One Hundred Million Dollars (\$100,000,000.00), * * * a
35 salary of Thirty-two Thousand Dollars (\$32,000.00).

37 (2) When a member of the board of supervisors holds a valid
38 certificate for completion of the Leadership Program for County
39 Supervisors administered by the Center for Governmental
40 Technology, Mississippi State University Extension Service, the
41 member may receive, in the member's discretion, an annual
42 supplement in the amount of One Thousand Five Hundred Dollars
43 (\$1,500.00), beginning with the next fiscal year following the
44 member's completion of the program.

45 **SECTION 2.** The Attorney General of the State of Mississippi
46 shall submit this act, immediately upon approval by the Governor,
47 or upon approval by the Legislature subsequent to a veto, to the
48 Attorney General of the United States or to the United States
49 District Court for the District of Columbia in accordance with the
50 provisions of the Voting Rights Act of 1965, as amended and
51 extended.

52 **SECTION 3.** This act shall take effect and be in force from
53 and after October 1, 2002, if it is effectuated on or before that
54 date under Section 5 of the Voting Rights Act of 1965, as amended
55 and extended. If it is effectuated under Section 5 of the Voting
56 Rights Act of 1965, as amended and extended, after October 1,
57 2002, this act shall take effect and be in force from and after
58 the date it is effectuated under Section 5 of the Voting Rights
59 Act of 1965, as amended and extended.
