HOUSE BILL NO. 1178

- AN ACT TO CREATE NEW SECTION 27-19-56.32, MISSISSIPPI CODE OF
- 1972, TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE MOTOR VEHICLE
- LICENSE TAGS TO MEMBERS OF THE PRINCE HALL GRAND LODGE OF 3
- MISSISSIPPI, FREE AND ACCEPTED ANCIENT YORKRITE MASONS; TO PRESCRIBE AN ADDITIONAL FEE FOR THE ISSUANCE OF SUCH DISTINCTIVE 4

- LICENSE TAGS; TO PROVIDE FOR THE DISTRIBUTION OF THE ADDITIONAL 6
- 7 FEES; AND FOR RELATED PURPOSES.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- SECTION 1. The following shall be codified as Section 9
- 27-19-56.32, Mississippi Code of 1972: 10
- 27-19-56.32. (1) Any owner of a motor vehicle who is a 11
- member of the Prince Hall Grand Lodge of Mississippi, Free and 12
- Accepted Ancient Yorkrite Masons, upon complying with the motor 13
- vehicle laws relating to registration and licensing of motor 14
- 15 vehicles, and upon payment of the road and bridge privilege taxes,
- ad valorem taxes and registration fees as prescribed by law for 16
- private carriers of passengers, pickup trucks and other 17
- noncommercial motor vehicles, and upon payment of an additional 18
- annual fee in the amount of Thirty Dollars (\$30.00), shall be 19
- entitled to a special license tag which displays the Prince Hall 20
- Grand Lodge Mason emblem and displays the letters "F&AAYM." 21
- The tags shall be of such color and design as the State 22
- 23 Tax Commission shall prescribe subject to the approval of the
- Mississippi License Tag Commission. 24
- Application for the special license tags shall be made 25
- to the county tax collector on forms prescribed by the State Tax 26
- Commission. Applicants for such distinctive license tags shall 27
- 28 present to the issuing official documentation from the Free and
- Accepted Ancient Yorkrite Masons, Prince Hall Grand Lodge of 29

- Mississippi as prescribed by the State Tax Commission showing 30
- their membership in the Free and Accepted Ancient Yorkrite Masons, 31
- Prince Hall Grand Lodge of Mississippi. 32 The application and the
- additional fee, less Two Dollars (\$2.00) thereof to be retained by 33
- 34 the tax collector, shall be remitted to the State Tax Commission
- on a monthly basis as prescribed by the commission. The portion 35
- of the additional fee retained by the tax collector shall be 36
- deposited into the county general fund. 37
- The special license tag shall be issued for a one-year 38
- The additional annual fee shall be due and payable at the 39
- time of renewal registration. 40
- The State Tax Commission shall deposit all fees into the 41
- 42 State Treasury on the day received. At the end of each month, the
- State Tax Commission shall certify the total fees collected under 43
- this section to the State Treasurer who shall distribute such 44
- collections as follows: 45
- Twenty-five Dollars (\$25.00) of each additional fee 46
- 47 collected on special license tags shall be deposited in a special
- fund hereby created in the State Treasury to the credit of the 48
- 49 Free and Accepted Ancient Yorkrite Masons, Prince Hall Grand Lodge
- of Mississippi. The funds shall be available for expenditure at 50
- 51 the discretion of the Prince Hall Grand Lodge of Mississippi.
- The remainder of each such additional fee shall be 52
- deposited to the credit of the State Highway Fund to be expended 53
- 54 solely for the repair, maintenance, construction or reconstruction
- of highways. 55
- SECTION 2. This act shall take effect and be in force from 56

and after July 1, 2002. 57
