COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 1236

AN ACT TO AMEND SECTIONS 63-5-13 AND 63-5-19, MISSISSIPPI
CODE OF 1972, TO INCREASE THE MAXIMUM WIDTH AND LENGTH LIMITATIONS
FOR CERTAIN VEHICLES DESIGNED AND ESPECIALLY CONSTRUCTED TO
TRANSPORT RAW COTTON FROM HARVEST TO THE COTTON GIN WHENEVER ANY
SUCH VEHICLE IS BEING OPERATED WITHIN A RADIUS OF FIFTY MILES OF
THE VEHICLE'S HOME BASE OR ITS CONTRACTUAL CUSTOMER; AND FOR
RELATED PURPOSES.

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 63-5-13, Mississippi Code of 1972, is 10 amended as follows:
- 11 63-5-13. (1) Except as otherwise provided in this section,
- 12 the total outside width of any vehicle, exclusive of required
- 13 safety devices, or the load thereon shall not exceed eight and
- 14 one-half (8-1/2) feet; provided, however, that appurtenances on
- 15 recreational vehicles shall be allowed so long as they are inside
- 16 the exterior rearview mirrors of the recreational vehicle or
- 17 inside the exterior rearview mirrors of the vehicle towing the
- 18 recreational vehicle, and such mirrors do not extend further than
- 19 necessary to obtain the appropriate field of view.
- 20 (2) The total outside load width of any vehicle hauling
- 21 unprocessed forest products on public roads, streets or highways,
- 22 other than interstate highways, shall not exceed nine and one-half
- 23 (9-1/2) feet if such products may not be shortened without
- 24 rendering them useless for the end product for which they were
- 25 cut; provided, however, the total outside vehicle width of such a
- 26 vehicle, exclusive of required safety devices and the load of such
- 27 vehicle, shall not exceed eight and one-half (8-1/2) feet.
- 28 (3) The total outside width of a farm tractor shall not
- 29 exceed ten (10) feet, except that farm tractors shall not be

- 30 operated upon the interstate highways without a special permit
- 31 from the Mississippi Department of Transportation.
- 32 (4) A vehicle designed and especially constructed to
- 33 transport raw cotton from harvest to the cotton gin may have a
- 34 total outside width not to exceed nine (9) feet whenever any such
- 35 vehicle is being operated within a radius of fifty (50) miles of
- 36 the vehicle's home base or its contractual customer.
- 37 **SECTION 2.** Section 63-5-19, Mississippi Code of 1972, is
- 38 amended as follows:
- 39 63-5-19. (1) Except as otherwise provided in this section,
- 40 no single vehicle, unladen or with load, shall have an overall
- 41 length, inclusive of front and rear bumpers, in excess of forty
- 42 (40) feet.
- 43 (2) No semitrailer operating in a truck tractor-semitrailer
- 44 combination and no trailer drawn by a motor vehicle shall exceed a
- 45 length of fifty (50) feet.
- 46 (3) No semitrailer or trailer operating in a truck
- 47 tractor-semitrailer-trailer combination and no trailer operating
- 48 in a double trailer combination drawn by a motor vehicle shall
- 49 exceed a length of thirty (30) feet.
- 50 (4) No semitrailer or trailer combinations in excess of two
- 51 (2) units, excluding the towing motor vehicle, shall be allowed to
- 52 operate on the highways of this state.
- 53 (5) No motor home shall have an overall length exclusive of
- 54 front and rear bumpers, in excess of forty-five (45) feet.
- 55 (6) The load upon the rear vehicle of a combination of
- 56 vehicles transporting forest or agricultural products in their
- 57 natural state shall not project more than twenty-eight (28) feet
- 58 beyond the rear axle of the vehicle except in the special
- 59 circumstance hereinafter prescribed. If such products project
- 60 more than twenty-eight (28) feet beyond the rear axle and, due to
- 61 the end use for which they are intended (such as tall utility
- 62 poles or light poles or the like), such products cannot be

- 63 shortened without rendering them useless for the finished product
- 64 for which they have been cut, then such special circumstance may
- 65 be considered good cause for the obtaining of a permit which shall
- 66 be procured pursuant to Section 63-5-51 before vehicles
- 67 transporting such products may operate. Except as otherwise
- 68 provided in Section 63-5-21, any vehicle transporting projecting
- 69 loads as described in this subsection that extend four (4) feet or
- 70 more beyond the rear or body of the vehicle shall operate only
- 71 during daylight hours, and the load on vehicles designed to
- 72 transport forestry products shall be secured by at least two (2)
- 73 chains, two (2) wire ropes, or two (2) nylon straps, one (1)
- 74 positioned behind the front bolster and one (1) in front of the
- 75 back bolster.
- 76 (7) Except as otherwise provided in Section 63-5-21, the
- 77 rear projecting load of any vehicle operating during the period
- 78 described under Section 63-7-11 may not extend four (4) feet or
- 79 more beyond the rear or body of the vehicle.
- 80 (8) The length limitations on projecting loads prescribed in
- 81 this section do not apply to a single vehicle or the rear vehicle
- 82 of a combination of vehicles designed for on-farm delivery and
- 83 unloading of any agricultural product, in its natural or
- 84 manufactured form, which is fitted with an auger or similar
- 85 unloading device permanently affixed to the vehicle that extends
- 86 no more than eight (8) feet horizontally beyond the rear or body
- 87 of the vehicle provided that no portion of such device which
- 88 extends four (4) feet or more beyond the rear or body of the
- 89 vehicle is less than seven (7) feet above the roadway surface.
- 90 However, any such vehicle may not be operated on the public
- 91 highways, roads or streets of this state during the period
- 92 described under Section 63-7-11.
- 93 (9) A vehicle designed and especially constructed to

- 94 transport raw cotton from harvest to the cotton gin may have a
- 95 total overall length not to exceed fifty (50) feet whenever any

- 96 such vehicle is being operated within a radius of fifty (50) miles
- of the vehicle's home base or its contractual customer. 97
- SECTION 3. This act shall take effect and be in force from 98
- and after July 1, 2002. 99
