## HOUSE BILL NO. 1365

- AN ACT TO ENACT THE FAIR TRADE PRACTICE ACT FOR PROCUREMENT OF CONTACT LENS; RELATING TO THE RIGHTS OF CONSUMERS TO PROCURE
- 3 CONTACT LENSES FROM PERSONS OR COMPANIES OF THEIR CHOICE; TO
- 4 AUTHORIZE PRESCRIPTIONS TO BE TRANSFERRED OR VERIFIED BY
- 5 ELECTRONIC MEANS; TO REQUIRE THE RELEASE OF CONTACT LENS
- 6 PRESCRIPTIONS; TO REQUIRE EYE CARE PROFESSIONALS TO VERIFY OR
- 7 CONFIRM PRESCRIPTION INFORMATION TO CONTACT LENS PROVIDERS OR
- 8 OTHER EYE CARE PROFESSIONALS; TO AMEND SECTION 73-19-61, IN
- 9 CONFORMITY THERETO; AND FOR RELATED PURPOSES.
- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 11 SECTION 1. The following words and phrases shall have the
- 12 meanings ascribed in this unless the context clearly indicates
- 13 otherwise:
- 14 (a) "Contact lens" means a medical device placed on the
- 15 eye.
- 16 (b) "Contact lens prescription" means a written or
- 17 verbal communication issued by an eye care professional,
- 18 authorized to issue prescriptions, setting forth all of the
- 19 necessary information to dispense or prepare contact lenses for
- 20 the consumer.
- 21 <u>SECTION 2.</u> (1) A prescription is required before contacts
- 22 may be dispensed to any individual.
- 23 (2) A contact lens prescription may not contain an
- 24 expiration date which is less than two (2) years from the date of
- 25 issue unless, in the medical judgment of the eye care
- 26 professional, there is a medical reason for a shorter period of
- 27 time. In the event a prescription is issued for a period of less
- 28 than two (2) years, the medical reason must be explained to the
- 29 patient in writing, and a signed copy of such explanation shall be
- 30 preserved in the patient's medical record.

SECTION 3. (1) Eye care professionals authorized under 31 32 state law to issue contact lens prescriptions, upon determining the parameters of the lens, shall provide the patient with a 33 contact lens prescription containing all of the necessary 34 35 information for any eye care professional or contact lens 36 replacement provider to dispense lenses to the customer. event an expiration date is not included on the prescription the 37 prescription shall expire two (2) years after the date of issue. 38 (2) When requested by another eye care professional, 39 optical dispenser or contact lens provider, to confirm 40 prescription information for a specified individual, the eye care 41 professional shall confirm all necessary information to enable the 42 43 person requesting verification to accurately dispense the contact Confirmation may be requested and responded to in any 44 lenses. written form, including by electronic means, such as facsimile or 45 e-mail transmission. In the event confirmation is not made within 46 one (1) hour following the request, all information contained in 47 the request, including the fact that the prescription has not 48 expired, shall be presumed as accurate, and the eye care 49 50 professional or replacement contact lens provider shall be authorized to dispense lenses pursuant to the prescription. 51 52 In the event contact lenses are dispensed pursuant to a prescription at a time when the eye care professional's 53 office is closed, and the eye care professional later determines 54 55 that there is a problem with the prescription, the eye care professional shall notify the dispenser in any written form, 56 57 including by electronic means such as facsimile or e-mail transmission, of the problem. Upon receipt of such notification, 58 the dispenser shall notify the customer in any written form, 59 including by electronic means such as facsimile or e-mail 60 transmission, provide a copy of the eye care professional's 61 62 notification, and advise the consumer to return to his or her eye care professional for follow-up care. - 64 who informs the dispenser of the problem is relieved of all
- 65 liability as a result of the dispenser's reliance on the presumed
- 66 confirmation.
- 67 **SECTION 4.** All eye care professionals who issue
- 68 prescriptions for contact lenses shall post a notice, no smaller
- 69 than one-half (1/2) inch type in the location where payment for
- 70 services is made, informing patients as follows: "Following the
- 71 final fitting of your contact lenses you have a right to receive a
- 72 copy of your contact lens prescription."
- 73 SECTION 5. Section 73-19-61, Mississippi Code of 1972, is
- 74 amended as follows:
- 75 73-19-61. It shall be unlawful for any person, persons,
- 76 corporation, proprietorship, partnership, or any entity other than
- 77 a licensed optometrist or licensed ophthalmologist to \* \* \*
- 78 prescribe to the public contact lenses, or to dispense, fit or
- 79 prescribe any medical appliance having direct contact with the
- 80 cornea of the eye. However, an optical dispenser or contact lens
- 81 provider may \* \* \* fill the written contact lens prescription of a
- 82 licensed optometrist or licensed ophthalmologist provided that
- 83 such optical dispenser or contact lens provider complies with the
- 84 provisions of Sections 1 through 4 of this act.
- 85 **SECTION 6.** This act shall take effect and be in force from
- 86 and after July 1, 2002.
