HOUSE BILL NO. 1566

- AN ACT TO CODIFY SECTION 97-27-10, MISSISSIPPI CODE OF 1972, TO DEFINE CERTAIN TERMS; TO AMEND SECTION 97-27-11, MISSISSIPPI CODE OF 1972, TO PROHIBIT THE INTRODUCTION OF HARMFUL BIOLOGICAL 3 SUBSTANCES INTO MISSISSIPPI, TO PROHIBIT THE UNLAWFUL POSSESSION OF SUCH HARMFUL BIOLOGICAL SUBSTANCES, AND TO INCREASE THE PENALTIES ASSOCIATED WITH SUCH PROHIBITED ACTS; TO CODIFY SECTION 6 7 97-27-12, MISSISSIPPI CODE OF 1972, TO MAKE UNLAWFUL THE PERFORMING OF AN ACT INTENDED TO CAUSE A PERSON TO FALSELY BELIEVE 8 THAT THE PERSON HAS BEEN EXPOSED TO A HARMFUL BIOLOGICAL, CHEMICAL 9 10 OR RADIOLOGICAL SUBSTANCE OR DEVICE, TO PROVIDE CRIMINAL PENALTIES AND TO IMPOSE THE COSTS OF INDIVIDUAL AND GOVERNMENTAL RESPONSE TO 11 SUCH UNLAWFUL ACTS; AND FOR RELATED PURPOSES. 12
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 14 SECTION 1. The following shall be codified as Section
- 15 97-27-10, Mississippi Code of 1972:
- 16 <u>97-27-10.</u> As used in Sections 97-27-10 through 97-27-12:
- 17 (a) "Harmful biological substance" means a bacteria,
- 18 virus, or other microorganism or a toxic substance derived from or
- 19 produced by an organism that can be used to cause death, injury,
- 20 or disease in humans, animals or plants.
- 21 (b) "Harmful biological device" means a device designed
- 22 or intended to release a harmful biological substance.
- (c) "Harmful chemical substance" means a solid, liquid,
- 24 or gas that through its chemical or physical properties, along or
- 25 in combination with one or more other chemical substances, can be
- 26 used to cause death, injury, or disease in humans, animals or
- 27 plants.
- 28 (d) "Harmful radioactive material" means material that
- 29 is radioactive and that can be used to cause death, injury, or
- 30 disease in humans, animals or growing plants by its radioactivity.
- 31 (e) "Harmful chemical device" means a device that is
- 32 designed or intended to release a harmful chemical substance.

- 33 (f) "Harmful radioactive device" means a device that is
- 34 designed or intended to release a harmful radioactive material.
- 35 **SECTION 2.** Section 97-27-11, Mississippi Code of 1972, is
- 36 amended as follows:
- 37 97-27-11. (1) It shall be unlawful for any person to
- 38 willfully and knowingly import, bring or send into this state a
- 39 harmful biological substance including smallpox, anthrax or any
- 40 other contagious or infectious disease * * *, with the design to
- 41 <u>unlawfully</u> spread the same <u>or assist in spreading the same with</u>
- 42 intent to cause harm to human, animal or plant life and it shall
- 43 likewise be unlawful for any person to develop, manufacture or
- 44 possess such harmful biological substances, except for purposes
- 45 authorized by law.
- 46 (2) A person convicted of subsection (1) shall be guilty of
- 47 <u>a felony and, upon conviction, shall</u> be fined not more than <u>One</u>
- 48 Hundred Thousand Dollars (\$100,000.00), and be imprisoned not more
- 49 than twenty (20) years in the State Penitentiary, or both.
- 50 **SECTION 3.** The following shall be codified as Section
- 51 97-27-12, Mississippi Code of 1972:
- 52 97-27-12. (1) It shall be unlawful for any person to commit
- 53 an act intended to cause another person or persons to falsely
- 54 believe that said person or persons have been exposed to a harmful
- 55 biological substance, harmful biological device, harmful chemical
- 56 substance, harmful chemical device, harmful radioactive material
- 57 or harmful radioactive device.
- 58 (2) Any person convicted of subsection (1) of this section
- 59 shall be guilty of a felony, and, upon conviction, shall be
- 60 punished by imprisonment in the State Penitentiary for not more
- 61 than five (5) years or shall be fined not more than Ten Thousand
- 62 Dollars (\$10,000.00), or both.
- 63 (3) In addition to any such imprisonment and/or fine which
- 64 may be imposed upon a violation of subsection (1) of this section,
- 65 the court shall also order than any person convicted for such

- of violation shall reimburse any individual or governmental agency
- 67 for the expenses incurred as a result of the violation.
- SECTION 4. This act shall take effect and be in force from
- 69 and after its passage.
