HOUSE BILL NO. 1761

1 AN ACT APPROVING THE EXPENDITURE OF SPECIAL FUNDS FOR THE
2 PURPOSE OF DEFRAYING THE EXPENSES OF THE YELLOW CREEK STATE INLAND
3 PORT AUTHORITY FOR THE FISCAL YEAR 2003.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 **SECTION 1.** The following sum, or so much thereof as may be
6 necessary, is hereby authorized and approved for expenditure out
7 of any funds which are received by or otherwise become available
8 to the Yellow Creek State Inland Port Authority, for the purpose
9 of defraying the expenses of the Authority for the fiscal year
10 beginning July 1, 2002, and ending June 30, 2003.....
11 \$ 4,710,390.00.

12 **SECTION 2.** Of the funds approved for expenditure under the
13 provisions of Section 1, not more than the amounts set forth below
14 shall be expended for the respective major objects or purposes of
15 expenditure:

32 Any transfers or escalations shall be made in accordance with
33 the terms, conditions and procedures established by law.

34 No general funds authorized to be expended herein shall be
35 used to replace federal funds and/or other special funds which are
36 being used for salaries authorized under the provisions of this
37 act and which are withdrawn and no longer available.

38 **SECTION 3.** It is the intention of the Legislature that the
39 Yellow Creek State Inland Port Authority be allowed to escalate
40 its budget in the "Capital Outlay: Equipment" major object of
41 expenditure for a crane, with funds from any source not to exceed
42 One Million Dollars (\$1,000,000.00). This escalation shall be in
43 accordance with rules and regulations of the Department of Finance
44 and Administration in a manner consistent with the escalation of
45 federal funds.

46 **SECTION 4.** The money herein approved for expenditure shall
47 be disbursed upon bank checks signed by the proper person, officer
48 or officers, in the manner provided by law.

49 **SECTION 5.** This act shall take effect and be in force from
50 and after July 1, 2002.
