HOUSE BILL NO. 1780

AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE 1 STATE TREASURY FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE 2 3 PUBLIC UTILITIES STAFF FOR THE FISCAL YEAR 2003. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 4 SECTION 1. The following sum, or so much thereof as may be 5 necessary, is hereby appropriated out of any money in the State 6 Treasury to the credit of the Public Utilities Staff Regulation 7 8 Fund, for the purpose of defraying the expenses of the Public Utilities Staff for the fiscal year beginning July 1, 2002, and 9 ending June 30, 2003..... 10 .....\$ 11 1,881,126.00. SECTION 2. Funds are provided herein to adjust the Variable Compensation Plan to ensure that all full-time employees receive a pay increase equal to fifty percent (50%) of the realignment component of the Variable Compensation Plan or Six Hundred Dollars (\$600.00), whichever is greater, beginning on January 1, 2003.

With the funds herein appropriated, it is the intention of 37 38 the Legislature that it shall be the agency's responsibility to make certain that funds required to be appropriated for "Personal 39 Services" for Fiscal Year 2004 do not exceed Fiscal Year 2003 40 funds appropriated for that purpose, unless programs, positions or 41 pay increases are added to the agency's budget by the Mississippi 42 Legislature. Based on data provided by the Legislative Budget 43 Office, the State Personnel Board shall, on July 1, 2002, publish 44 45 separate annual projection reports, based on July 1, 2002 data, for the period of July 1, 2002 through December 31, 2002, and 46 47 January 1, 2003 through June 30, 2003, that project the annual cost to fully fund all appropriated positions in compliance with 48 49 the provisions of this act. It shall be the responsibility of the agency head to ensure that no single personnel action increases 50 this projected cost and/or the Fiscal Year 2003 appropriation for 51 52 "Personal Services," as annualized on a semi-annual basis in accordance with the provisions of this act. If, at the end of any 53 calendar month, the State Personnel Board determines that the 54 agency has taken action(s) which would cause the agency to exceed 55 this projected annual cost or the Fiscal Year 2003 "Personal 56 57 Services" appropriated level, when annualized in compliance with the provisions of this act, then only those actions which reduce 58 59 the projected annual cost and/or the appropriation requirement

will be processed by the State Personnel Board until such time asthe requirements of this provision are met.

62 Any transfers or escalations shall be made in accordance with 63 the terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

68 SECTION 3. The money herein appropriated shall be paid by 69 the State Treasurer out of any money in the State Treasury to the 70 credit of the proper fund or funds as set forth in this act, upon 71 warrants issued by the State Fiscal Officer; and the State Fiscal 72 Officer shall issue his warrants upon requisitions signed by the 73 proper person, officer or officers in the manner provided by law.

74 SECTION 4. This act shall take effect and be in force from75 and after July 1, 2002.
