HOUSE BILL NO. 1787

1 AN ACT MAKING AN APPROPRIATION FOR THE PURPOSE OF DEFRAYING  
2 THE EXPENSES OF THE STATE DEPARTMENT OF HEALTH FOR THE FISCAL YEAR  
3 2003.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 SECTION 1. The following sum, or so much thereof as may be  
6 necessary, is hereby appropriated out of any money in the State  
7 General Fund not otherwise appropriated, for the purpose of  
8 defraying the expenses of the State Department of Health for the  
9 fiscal year beginning July 1, 2002, and ending June 30, 2003.....

10 ..... \$ 30,715,240.00.

11 SECTION 2. The following sum, or so much thereof as may be  
12 necessary, is hereby appropriated out of any money in any special  
13 fund in the State Treasury to the credit of the State Department  
14 of Health which is comprised of special source funds collected by  
15 or otherwise available to the department, for the purpose of  
16 defraying the expenses of the department for the fiscal year  
17 beginning July 1, 2002, and ending June 30, 2003.....

18 ..... \$ 172,676,661.00.

19 SECTION 3. The following sum, or so much thereof as may be  
20 necessary, is hereby appropriated out of any money in the State  
21 Treasury to the credit of the Health Care Expendable Fund, for the  
22 purpose of defraying the expenses of the State Board of Health for  
23 the fiscal year beginning July 1, 2002, and ending June 30, 2003.

25 The above funds shall be allocated as follows:

26 Maternal and Child Health Care  
27 Program.....\$1,400,000.00



28 Early Intervention Program.....\$ 250,000.00  
 29 Health Department Programs.....\$2,500,000.00  
 30 Mississippi Qualified Health  
 31 Center Grant Program.....\$4,000,000.00  
 32 Trauma Care System.....\$6,000,000.00

33 It is the intention of the Legislature that none of the Six  
 34 Million Dollars (\$6,000,000.00) authorized herein for the Trauma  
 35 Care System shall be expended to the benefit of any hospital  
 36 located outside the boundaries of the State of Mississippi.  
 37 Further, no such out-of-state hospital shall be authorized to  
 38 receive such funds until such time as the amount appropriated for  
 39 such purpose shall reach an amount of Eight Million Dollars  
 40 (\$8,000,000.00) or more.

41 **SECTION 4.** Of the funds appropriated under the provisions of  
 42 Sections 1, 2 and 3, not more than the amounts set forth below  
 43 shall be expended for the respective major objects or purposes of  
 44 expenditure:

65 Funds are provided herein to adjust the Variable Compensation  
66 Plan to ensure that all full-time employees receive a pay increase  
67 equal to fifty percent (50%) of the realignment component of the  
68 Variable Compensation Plan or Six Hundred Dollars (\$600.00),  
69 whichever is greater, beginning on January 1, 2003.

70 With the funds herein appropriated, it is the intention of  
71 the Legislature that it shall be the agency's responsibility to  
72 make certain that funds required to be appropriated for "Personal  
73 Services" for Fiscal Year 2004 do not exceed Fiscal Year 2003  
74 funds appropriated for that purpose, unless programs, positions or  
75 pay increases are added to the agency's budget by the Mississippi  
76 Legislature. Based on data provided by the Legislative Budget  
77 Office, the State Personnel Board shall, on July 1, 2002, publish  
78 separate annual projection reports, based on July 1, 2002 data,  
79 for the period of July 1, 2002 through December 31, 2002, and  
80 January 1, 2003 through June 30, 2003, that project the annual  
81 cost to fully fund all appropriated positions in compliance with  
82 the provisions of this act. It shall be the responsibility of the  
83 agency head to ensure that no single personnel action increases  
84 this projected cost and/or the Fiscal Year 2003 appropriation for  
85 "Personal Services," as annualized on a semi-annual basis in  
86 accordance with the provisions of this act. If, at the end of any  
87 calendar month, the State Personnel Board determines that the  
88 agency has taken action(s) which would cause the agency to exceed  
89 this projected annual cost or the Fiscal Year 2003 "Personal  
90 Services" appropriated level, when annualized in compliance with  
91 the provisions of this act, then only those actions which reduce  
92 the projected annual cost and/or the appropriation requirement



93 will be processed by the State Personnel Board until such time as  
94 the requirements of this provision are met.

95 Any transfers or escalations shall be made in accordance with  
96 the terms, conditions and procedures established by law.

97 No general funds authorized to be expended herein shall be  
98 used to replace federal funds and/or other special funds which are  
99 being used for salaries authorized under the provisions of this  
100 act and which are withdrawn and no longer available.

101 **SECTION 5.** In compliance with the "Mississippi Performance  
102 Budget and Strategic Planning Act of 1994," it is the intent of  
103 the Legislature that the funds provided herein shall be utilized  
104 in the most efficient and effective manner possible to achieve the  
105 intended mission of this agency. Based on the funding authorized,  
106 this agency shall make every effort to attain the targeted  
107 performance measures provided below:

134 A reporting of the degree to which the performance targets  
135 set above have been or are being achieved shall be provided in the  
136 agency's budget request submitted to the Joint Legislative Budget  
137 Committee for Fiscal Year 2004.

138 **SECTION 6.** It is the intention of the Legislature that the  
139 State Department of Health may escalate any special funds and  
140 positions not to exceed Two Million Dollars (\$2,000,000.00). Such  
141 escalation shall be submitted to and approved by the Department of  
142 Finance and Administration in the manner consistent with the  
143 escalation of federal funds.

144 **SECTION 7.** It is the intention of the Legislature that the  
145 Department of Health shall have the authority to expend any  
146 special funds collected or otherwise available, notwithstanding  
147 any restrictions in the general law or statutes earmarking said  
148 funds for a particular use, that are in excess of the amounts  
149 needed for the purpose of such fund, for the purpose of providing  
150 maternal and child health, family planning and disease control  
151 services.

152 **SECTION 8.** It is the intention of the Legislature that with  
153 the funds provided herein, the State Department of Health may  
154 provide and administer without charge, Hepatitis B vaccinations to  
155 Emergency Medical Services (EMS) personnel who are in need of such  
156 vaccinations through job related exposure.

157 **SECTION 9.** In addition to all other sums heretofore  
158 appropriated, the following sum, or so much thereof as may be



159 necessary, is hereby appropriated out of any money in the State  
160 Treasury to the credit of the Local Governments and Rural Water  
161 Systems Emergency Loan Fund, and the Local Governments and Rural  
162 Water System Improvements Revolving Loan Fund as authorized in  
163 Chapter 521, Laws of 1995, to the State Department of Health for  
164 the purpose of defraying the expenses of the Local Governments and  
165 Rural Water Systems Improvements Board, for the fiscal year  
166 beginning July 1, 2002, and ending June 30, 2003.....  
167 ..... \$ 33,552,000.00

168 **SECTION 10.** It is the intention of the Legislature that in  
169 the event that there are insufficient Child Care Development Block  
170 Grant Funds, then the Department of Health shall maintain the  
171 Child Care Licensure Program at the same level that the program  
172 was in Fiscal Year 1993 using any other funds.

173 **SECTION 11.** Of the funds appropriated in Section 2, One  
174 Million Dollars (\$1,000,000.00) shall come from the Department of  
175 Human Services, Child Care Development Fund or other appropriate  
176 special funds for the purpose of child care licensure. These  
177 funds are to be transferred to the State Department of Health no  
178 later than July 31, 2002. The State Department of Health shall  
179 make a complete accounting of the uses of these funds to the  
180 Department of Human Services.

181 **SECTION 12.** It is the intention of the Legislature that the  
182 State Department of Health shall expend not more than Fifty  
183 Thousand Dollars (\$50,000.00) of the funds appropriated in Section  
184 1 and allocated in Section 4 for providing the oil known as  
185 "Lorenzo's Oil" for the treatment of the genetic disorder  
186 adrenoleukodystrophy (ALD), to children and Mississippi residents  
187 over the age of twenty-one (21) who have the genetic disorder  
188 adrenoleukodystrophy and for whom Medicaid does not reimburse the  
189 cost of providing the oil. The department may also provide needed  
190 pathology and biannual MRI exams.



191           **SECTION 13.** In addition to all other funds heretofore  
192 appropriated, the following sum, or so much thereof as may be  
193 necessary, is hereby appropriated out of any money deposited in  
194 the State Treasury from the Mississippi Tobacco Pilot Program as  
195 authorized in the case Mike Moore Attorney General ex rel. State  
196 of Mississippi v. The American Tobacco Company et al. (Chancery  
197 Court of Jackson County, Mississippi, Cause No. 94-1429) to the  
198 State Department of Health for the fiscal year beginning  
199 July 1, 2002, and ending June 30, 2003..... \$ 8,000,000.00.

200           It is the intention of the Legislature that of the funds  
201 appropriated in this section, an amount of Two Million Five  
202 Hundred Thousand Dollars (\$2,500,000.00) is provided to fund the  
203 School Tobacco Nurse Program.

204           **SECTION 14.** Of the funds appropriated in Section 1, Seven  
205 Hundred Fifty Thousand Dollars (\$750,000.00) are provided for the  
206 purpose of purchasing AIDS drugs only and not for educational  
207 purposes.

208           **SECTION 15.** Of the funds appropriated in Section 3, the  
209 amounts of One Hundred Twenty-five Thousand Dollars (\$125,000.00)  
210 shall be allocated to the T. K. Martin Center at Mississippi State  
211 University and One Hundred Twenty-five Thousand Dollars  
212 (\$125,000.00) shall be allocated to the Regional Rehabilitation  
213 Center in Tupelo for the Early Intervention Program.

214           **SECTION 16.** Of the funds appropriated herein, Fifty Thousand  
215 Dollars (\$50,000.00) is provided for the Osteoporosis Program.

216           **SECTION 17.** In addition to all other funds heretofore  
217 appropriated, the following sum, or so much thereof as may be  
218 necessary, is hereby appropriated out of any money in any special  
219 fund in the State Treasury to the credit of the State Department  
220 of Health which is comprised of special source funds collected by  
221 or otherwise available to the department, for the purpose of  
222 funding the Federal Bioterrorism Preparedness Program to the State



223 Department of Health for the fiscal year beginning July 1,  
224 2002, and ending June 30, 2003..... \$ 12,300,000.00.

225 **SECTION 18.** The money herein appropriated shall be paid by  
226 the State Treasurer out of any money in the State Treasury to the  
227 credit of the proper fund or funds as set forth in this act, upon  
228 warrants issued by the State Fiscal Officer; and the State Fiscal  
229 Officer shall issue his warrants upon requisitions signed by the  
230 proper person, officer or officers, in the manner provided by law.

231 **SECTION 19.** This act shall take effect and be in force from  
232 and after July 1, 2002.
