HOUSE BILL NO. 1815

1 AN ACT MAKING AN ADDITIONAL APPROPRIATION FROM THE WORKING  
2 CASH-STABILIZATION RESERVE FUND TO THE STATE DEPARTMENT OF  
3 EDUCATION FOR THE PURPOSE OF FUNDING THE MINIMUM EDUCATION  
4 PROGRAM, THE MISSISSIPPI ADEQUATE EDUCATION PROGRAM AND THE  
5 CHICKASAW SCHOOL FUND FOR THE FISCAL YEAR 2002.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** In addition to all other sums previously  
8 appropriated, the following sum, or so much of it as may be  
9 necessary, is appropriated out of any money in the Working  
10 Cash-Stabilization Reserve Fund created in Section 27-103-203,  
11 Mississippi Code of 1972, that is not otherwise appropriated, to  
12 the State Department of Education for the purpose of funding the  
13 Minimum Education Program for the fiscal year ending June 30, 2002  
14 ..... \$45,550,984.00.

15 **SECTION 2.** This additional appropriation is made for the  
16 purpose of restoring cuts made by the Governor on February 11,  
17 2002, to the Minimum Education Program.

18 **SECTION 3.** In addition to all other sums previously  
19 appropriated, the following sum, or so much of it as may be  
20 necessary, is appropriated out of any money in the Working  
21 Cash-Stabilization Reserve Fund created in Section 27-103-203,  
22 Mississippi Code of 1972, that is not otherwise appropriated, to  
23 the State Department of Education for the purpose of funding the  
24 Mississippi Adequate Education Program for the fiscal year ending  
25 June 30, 2002..... \$ 3,505,554.00.

26 **SECTION 4.** This additional appropriation is made for the  
27 purpose of restoring cuts made by the Governor on February 11,  
28 2002, to the Mississippi Adequate Education Program.



29           **SECTION 5.** In addition to all other sums previously  
30 appropriated, the following sum, or so much of it as may be  
31 necessary, is appropriated out of any money in the Working  
32 Cash-Stabilization Reserve Fund created in Section 27-103-203,  
33 Mississippi Code of 1972, that is not otherwise appropriated, to  
34 the State Department of Education for the purpose of paying annual  
35 compensation to the Chickasaw Cession counties for sixteenth  
36 section lands which they lost through sale by the state, as  
37 provided in Sections 29-3-137 through 29-3-141, Mississippi Code  
38 of 1972, for the fiscal year ending June 30, 2002.....  
39 ..... \$ 518,722.00.

40           **SECTION 6.** This additional appropriation is made for the  
41 purpose of restoring cuts made by the Governor on February 11,  
42 2002, to the Chickasaw School Fund.

43           **SECTION 7.** In addition to all other sums previously  
44 appropriated, the following sum, or so much of it as may be  
45 necessary, is appropriated out of any money in the Working  
46 Cash-Stabilization Reserve Fund created in Section 27-103-203,  
47 Mississippi Code of 1972, that is not otherwise appropriated, to  
48 the State Department of Education for the purpose of funding the  
49 Uniform Millage Assistance Grants Program for the fiscal year  
50 ending June 30, 2002..... \$ 1,070,001.00.

51           **SECTION 8.** This additional appropriation is made for the  
52 purpose of restoring cuts made by the Governor on February 11,  
53 2002, to the Uniform Millage Assistance Grants Program.

54           **SECTION 9.** The money appropriated by this act shall be paid  
55 by the State Treasurer out of any money in the Working  
56 Cash-Stabilization Reserve Fund that is not otherwise  
57 appropriated, upon warrants issued by the State Fiscal Officer;  
58 and the State Fiscal Officer shall issue his warrants upon  
59 requisitions signed by the proper person, officer or officers in  
60 the manner provided by law.



61           **SECTION 10.** This act shall take effect and be in force from  
62 and after its passage.
