## HOUSE BILL NO. 1887

AN ACT TO AMEND SECTION 5 OF HOUSE BILL NO. 1794, 2002 1 REGULAR SESSION, TO DELETE THE PROVISION THAT PROHIBITS THE 2 DIVISION OF MEDICAID FROM EXPENDING MORE THAN 25% OF ITS APPROPRIATED FUNDS DURING ANY QUARTER OF FISCAL YEAR 2003; AND FOR 3 4 5 RELATED PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 7 SECTION 1. Section 5 of House Bill No. 1794, 2002 Regular Session, is amended as follows: 8 Section 5. 33 \* \* \* In no event shall the Governor's Office - Division of Medicaid make any obligations for medical services which exceed 34 the total level of funds appropriated in this act, and the 35 Executive Director of the Division of Medicaid shall ensure 36 complete compliance with Section 43-13-117, Mississippi Code of 37 1972, by instituting cost containment measures or by discontinuing 38 39 authorized Medicaid programs to the extent allowed under federal law. 40

Funds are provided herein to adjust the Variable Compensation Plan to ensure that all full-time employees receive a pay increase equal to fifty percent (50%) of the realignment component of the Variable Compensation Plan or Six Hundred Dollars (\$600.00), whichever is greater, beginning on January 1, 2003.

46 With the funds herein appropriated, it is the intention of the Legislature that it shall be the agency's responsibility to 47 48 make certain that funds required to be appropriated for "Personal Services" for Fiscal Year 2004 do not exceed Fiscal Year 2003 49 50 funds appropriated for that purpose, unless programs, positions or pay increases are added to the agency's budget by the Mississippi 51 Legislature. Based on data provided by the Legislative Budget 52 53 Office, the State Personnel Board shall, on July 1, 2002, publish separate annual projection reports, based on July 1, 2002, data, 54 55 for the period of July 1, 2002, through December 31, 2002, and January 1, 2003, through June 30, 2003, that project the annual 56 57 cost to fully fund all appropriated positions in compliance with the provisions of this act. It shall be the responsibility of the 58 59 agency head to ensure that no single personnel action increases 60 this projected cost and/or the Fiscal Year 2003 appropriation for "Personal Services," as annualized on a semiannual basis in 61

If, at the end of any 62 calendar month, the State Personnel Board determines that the 63 agency has taken action(s) which would cause the agency to exceed 64 65 this projected annual cost or the Fiscal Year 2003 "Personal Services" appropriated level, when annualized in compliance with 66 the provisions of this act, then only those actions which reduce 67 the projected annual cost and/or the appropriation requirement 68 will be processed by the State Personnel Board until such time as 69 the requirements of this provision are met. 70

71 Any transfers or escalations shall be made in accordance with 72 the terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

77 SECTION 2. This act shall take effect and be in force from78 and after July 1, 2002.
