5	WHEREAS, Section 254, Mississippi Constitution of 1890,
6	requires that the Mississippi Legislature shall apportion itself
7	by joint resolution in the second year following the 1980
8	decennial census and every ten (10) years thereafter; and
9	WHEREAS, it is the responsibility and official mandate of the
10	Legislature to reapportion the state in compliance with the
11	one-person, one-vote requirement of the federal Constitution into
12	election districts as nearly equal as possible according to
13	population and in accordance with other factors heretofore
14	pronounced by the courts; and
15	WHEREAS, Section 254, Mississippi Constitution of 1890,
16	provides that the House of Representatives shall consist of not
17	more than one hundred twenty-two (122) Representatives, the number
18	of members to be determined by the Legislature:
